Dear Mr. Levi:

This is my request under the Freedom of Information Act for certain records relating to the assassination of President Kennedy. I write to you personally because I believe that the documents I seek are of considerable public importance. Each document has been quoted from and referred to publicly by a Senate committee and should be easy to identify. Consequently, I hope that my request can be complied with as soon as possible, avoiding the bureaucratic tangles that seem to accompany requests for less easily identified records.

All of the documents that I seek pursuant to this request have been cited in a report entitied "The Investigation of the Assassination of President John F. Kennedy: Performance of the Intelligence Agencies," which constitutes Book V of the Final Report of the Senate Select Committee to Study Governmental Operations with Respect to Intelligence Activities. It is dated April 23, 1976. Page references used throughout this request refer to the page of this Senate Report at which the particular document I desire is cited.

The documents of which I desire copies are the following:
