PAUL ROTHERMEL, AN EMPLOYEE OF H. L. HUNT CORPORATION,  
DALLAS, TEXAS, STATED THAT HE HAD HEARD FROM SOURCE HE  
WOULD NOT DISCLOSE THAT ABOUT SIX OR SEVEN YEARS AGO RUBY  
ATTENDED THE FUNERAL IN KENNEDY, TEXAS, OF A KNOWN UNDERWORLD  
FIGURE, DALLAS HUSKEY AKA HUSKEY. HUSKEY ALLEDGEDLY KILLED  
TWO PEOPLE SEVETEEN OR EIGHTEEN YEARS AGO, HAD CHICAGO  
LAWYER TO DEFEND HIM.

FOLLOWING PEOPLE ACCORDING TO ROTHERMEL IN KENNEDY,  
TEXAS, WILL KNOW OF RUBY-S ATTENDANCE OF HUSKEY-S FUNERAL  
COLON DOCTOR FNU MANLEY AND FNU RUTMAN.

SUBJECT: Jack Ruby--Victim  
Civil Rights

On 12/7/63, Captain O. A. Jones, Forgery Division, Dallas PD, furnished the following information.

Jack Ruby is reported to have been an associate of a man named Husky or Husky who died at Kennedy, Texas, 6 or 7 years ago. Ruby allegedly attended the funeral, and in attempting to locate the, Husky Ruby stopped at the house of a neighbor, Rutman.

Husky was attended by a Dr. Manley during his last sickness. Husky's father resided in Dallas years ago, and if still alive, probably resides here now. His widow and son supposedly live in Dallas now.

Husky is supposed to be from Chicago, and a number of Chicago hoodlums attended his funeral. He reportedly killed 2 men at Kennedy, 17 or 18 years ago, but was acquitted on self-defense. He engaged in gambling in the vicinity of Victoria, Kennedy. Later he went legitimate and was in the oil and cattle business.

Capt. Jones advised that he does not wish to reveal his source on the above information.

ACTION: Recommend filing this without action.

Dear Earl, *Golby*

I'm running a bit behind in doing what I intend doing with copies my wife makes from notes I attach as I read FBI records. I keep the originals as I get them, bound, in the basement. SO I'm not going to the trouble of getting the original of the two attached pages because I remember what was on the third, that the SAC was out of town at a law enforcement conference.

This is probably from FBIHQ assassination file, 62-109060, but as you can see it is not clear. The Serial is 737?, in Section ~~100~~ 182.

It appears that someone whose first name has seven letters and whose last name has three went running to the FBI with a report that appears to me to be distorted as the FBI put it on paper.

I know Paul and about some of his sources and some of what info was kicking around just before JFK got to Dallas. I suspect that what you were told or the actuality of what was being what you were told is that something like the Joiner deal was in the offing.

I also suspect that the FBI was more than usually uptight because this coincided with the leak of the Oswald letter to Hosty and his destruction of it and the Congressional hearing on that. That story broke 8/31/75. (Did you ever hear who leaked it?)

If this suggests anything to you let me know.

If you've had any stories lately I've not heard of them.

When you speak to Mary I hope she is coming a long well.
