Dear Harold:

Thanks for your letter of February 22. In view of your possible burglary, I am taking another look at mine, and in fact, my whole security setup.

The name you mentioned (Jimmy Robinson) has long been connected with the National States Rights Party. Some of the same people with the NSRP are also connected with the Minutemen. In addition, there are some dual memberships in the Klu Klux Klan, which has an active chapter in the Oak Cliff section of Dallas.

Brumley, mentioned in the attachment, is Maurice Brumley, a very capable investigator.

Several days ago, there was an explosion which scattered a number of Minutemen leaflets in downtown Dallas. If my secretary can locate this particular article, I will enclose it.

You are correct that these people are bad news, and it is a constant fight for me to keep people like these away from Mr. Hunt because they always come to him with a different story from what they really are. Once I know who they are Mr. Hunt has nothing further to do with them, but I am so thinly spread that I don't always know who sees him, especially on weekends.

You are quite correct in assessing the Clay Shaw trial, and I am afraid that your prediction will be very true.
