

CASE NO.

1. NOVEMBER 22, 1963
pronounced dead on or about 1:25 p.m.
J. F. Kennedy, Parkland Hospital, Dallas, Texas.
2. 1ST SHOT
Fired by assassin, struck President in back- not
hitting any vital organs.
3. 2ND SHOT
2nd bullet fired struck Gov. Connally of Texas.
4. 3RD SHOT
3rd shot fired was 2nd bullet to hit President-
tore through the skull, tearing right portion of fore-
head.
5. From time 2nd bullet and 1st bullet was fired-5 to 6
seconds intervals lapsed.
(IF STATEMENT IS TRUE, PRESIDENT KENNEDY COULD
HAVE DROPPED TO FLOOR OF CAR.)
6. After 2nd bullet hit President, Intelligence Officer
was also hit.

CONFIDENTIAL AND POSITIVE EVIDENCE

- A. Ballistic report shows President Kennedy was hit 3 times-
1st and 2nd shot hit Kennedy- was fired from 6.4 Italy
rifle. 3rd shot was fired from .25 automatic.
Identical wound was also found on Gov. Connally.
- B. Periodical theories indicates 2 people were involved in
shooting. Only 3 discharges shells were found-no
trace of ejected shells of .25 caliber were found.
- C. Less than an hour, Officer Tippit, Dallas Police Officer,
was shot to death by LEE HARVEY OSWALD.

DESCRIPTION OF OSWALD:

age-24, brown hair, brown eyes, 5'2 $\frac{1}{2}$ ". So-called "Self-
style Communist". Ex-U.S. Marine, SERIAL NO. 978443.
WAS DISHONORABLE DISCHARGED.
Was married in Russia to Russian-born wife.
PASSPORT NO. 11JE9997E.

- D. In October, Oswald made trip to Mexico City crossing border
at Nuevo-Larado. Visit consisted of visiting Russian
Ambassador. Tried to get visa back to Russia. Was
rejected by Russian Council. Also paid visit to Cuban
Ambassador, to get visa to Cuba. Was also rejected
there.
AFTER UNSUCCESSFUL TRIP, RETURNED TO U.S.A.

- E. After returning, OSWALD contacted "JACK B. ARMSTRONG", CANAL HOTEL, ROOM 53, 1157 CANAL ST., HOUSTON, TEXAS. Believed to have received small payment and instructions for assassin of Kennedy.
- F. Arrived in Dallas 2 weeks before the assassin took place. Got job at Texas Book Depository, which was place rifle was fired from.
- G. Visited RUBY'S CAROUSAL CLUB, twice. Last visit, witnesses saw OSWALD enter office. Was in office an hour and a half.
- H. After OSWALD was arrested, just 24 hours-he was shot to death by JACK RUBINSTEIN alias JACK RUBY, with .38 revolver. OSWALD died in Parkland Hospital. RUBY was arrested and charges with the murder of OSWALD.

CRIMINAL RECORD OF RUBY

WAS RAISED IN CHICAGO- at age of 15 convicted of assault and battery- served 6 months in reform school. Four weeks after release was convicted on charge of car thief. Served one year in reform school. At the age of 17, RUBY was card-holder of Nazi Party. Was arrested April 7, 1942 for conspiracy with enemy country. Was released for lack of evidence. From 1943 to 1952 records show JACK RUBINSTEIN card-holder No. 52 of COMMUNIST "FAIR-PLAY FOR CUBA". Also during this period he has been suspected of using "straw-man" places for contact to smuggle guns to CASTRO. In 1951, a letter written to CASTRO from RUBY is as follows:
 "Have shipment of rifles, sub-thompsons, and grenades. Will arrive in a few days."
 This letter was dated June 1, 1951.
