I have a microfilm of what is said to be the entire Texas-investigation file, from the library of longress. It isn't. But I spotted two things in it, the 12/21/63 Hall-Clements interview with luby (which I may not have located in the Archives-I do not remember), R-64 in the police file; and R82, a report by Jack Mevill that I copied anyway, even though I assumed you have it, on the chance you do not.

Because I do not know how you left, although I knew you planned to, if you think copies of these documents should be with funt and you'd prefer not to send them, let me know. I'l, be glad to. And if there is anything further you'd like from or done at the Archives, let me know and I'll tackle it. San't promise I'll succeed because they do not like me there. But, I sometimes find what they cannot and others do not.

Then you move to LA, let me know how to reach you. Someday somebody may have me out there to make a speech and perhaps we can get together again.

Curry's book was not a diseppointment to me because I look et it differently. I have often wondered it I had anything to do with it because, although he appears unflappable, I think I blew his mind a year ago November. In his appearances he has said what is important only because of his position: there is no proof Oswald was in that window. This is an enormous understatement, but coming from Curry it is significant. As I believe I told you, I hope that someday those Texas people who can afford it will help bring the truth out; not only in the national interest but in that of their State...I wondered more about this watching E. Ross Perot on TV yesterdey (despite his oft-repeated declaration of hat he seeks for the country I did not write him asking help).

I know you feel more free. If you decide to go ahead with your literary project and want me to do anything, ask it.

If you ever come accross snything you think would interest me, I hope you'll send it.
