I think that can be important but I also think it can be made up, that someone did it with a purpose in mind. I see no reason to believe that Oswald knew Ruby. But Mary is right-it should be looked into as much as is possible.

Glad you are enjoying O in MO. I had it finished about April or May, <sup>1967,</sup> ~~1967.~~  
Never got in most stores.

I have put much on paper about Garrison and if you are here again you are welcome to go over it. He was a great tragedy for himself and for us all, as some of us were in letting him con us. I should have realized earlier than I did. But how I did is quite a story. I've not put all the details on paper, if you are here and want to tape it but in brief, he was going to do worse than he had with Shaw to mark the 5th assassination anniversary! *Mary if she remembers, knows part of this.*

Please tell Barb that from recollection-which is not as dependable as it once was-a guy at the CIA named as I recall Dolan had something to do with its relations with the Commission. If so, probably later with the Archives.

Gary had not told me he is working on a book. Please tell him and Kathy they are welcome to use anything of mine they may want to. I just wrote Gary urging him to study the Zapruder film at about 345, two frames or so, where the back of the head is quite clear and it be able to disprove it before they get all ensnared in what they can not disprove. Lifton had an excellent print that as I told Gary he bragged about stealing.

If it were to simplify the most basic advice, and I'm deep into NEVER AGAIN! ~~proofs~~ proofs with a rush on them - it would be to go with Occam. Also spelled Ockham. About whose philosophy, paraphrased, ~~we~~ keep it simplest.

Glad you did not ask those questions! I'm much too busy now. Want the book to make their target, early April.

Doug,

Please understand that I have been examining and questioning these documents about 28 years and you have probably only been looking into them for a few years. What you have sent is wonderful!

The first document you sent is a 3-page document (note the fourth line: FROM SAC, ATLANTA /44-1559/ 3P) The 3P indicates that it is a 3-page document. You have only 2 pages.

The FBI file number "44" indicates: Civil Rights; Election Laws, Voting Rights Act, 1965; Overseas Citizens Voting Rights Act of 1975. The file number 44-1639 = the Dallas FBI file on Jack Ruby. The file number 44-24016 (which appears on the documents you sent to me) indicates the primary FBI file on Jack Ruby. Near the lower right corner of the first page of the document, you will see in pen 44-24016- and, in heavier pen, the number 138 which indicates it is the 138th page of the main Jack Ruby file. We need to ask Steve Tilley at the National Archives for the third page of this document (presumably 44-24016-140).

Each citizen is entitled to the first 100 pages of documents out of the National Archives free. I exhausted my freebies long ago. You might call Steve Tilley at the National Archives II in College Park, Maryland, and ask for this document. I don't think he would give you any problem. And, since Mike Garfield obtained it in 1988, it is very probable that you could get the un-redacted document now since the Review Board is forcing mass releases. Just last week Janet Reno released CD 1359 which we had been trying to get for the past 13 years. John Newman received the first copy and sent the second copy to me.

Ask for the entire 3 page document of 44-24016-138.

Doug, I do thank you for sending this document to me. It is potentially very, very important. Of course, it may be worthless, but that remains to be seen.

I have found two Marion Hayes in Georgia. Marion is usually a man's name but it is obvious that this woman spelled her name Marion. The only two I could find in Georgia were:

Doug,

I believe you will find that the name of the telephone operator was Marion Hayes. I base this on two pages of CD 897, pp. 411-412. I can't believe that there would be two such similar incidents. We need to see CD 897, p. 410, and I intend to try to get it out of the Archives. It relates a story of an Atlanta Southwestern Bell Long Distance Telephone operator named Marion Hayes who claimed she made calls attempting to reach Oswald and Ruby in New Orleans and Dallas from a person in Atlanta calling with a credit card.

As I said, we need to see page 410 because page 411 mentions the "foregoing information".

If you have a Xerox copy of the teletype, see if there are any handwritten numbers on it. Such as 105-36850, etc. or 100-12345, etc. If we can get the numbers from the document, we won't have any trouble getting the entire document from the National Archives.

NUMBER FOR OSWALD WERE UNSUCCESSFUL. CALLER THEN GAVE HER DALLAS

SAME CREDIT CARD NUMBER THEN ATTEMPTED TO REACH JACK RUBENSTEIN AT A NUMBER FURNISHED BY HIM IN DALLAS, TEXAS. NO ONE ANSWERED TELEPHONE AND CALLER ASKED HER TO CONTACT INFORMATION IN DALLAS FOR TELEPHONE NUMBER OF JACK RUBENSTEIN OR JACK RUBY STATING EVERYONE IN DALLAS WOULD KNOW HIM AS HE OPERATED A NIGHT CLUB.

[REDACTED] ADVISED THE INFORMATION OPERATOR WAS ABLE TO FURNISH HER A TELEPHONE NUMBER AND NO ONE ANSWERED THIS TELEPHONE. CALLER THEN INSTRUCTED HER TO CALL JACK RUBENSTEIN-S SISTER MYRTLE IN DALLAS, TEXAS, FURNISHING NUMBER. CALL WAS COMPLETED. APPROXIMATELY ONE P.M. SAME PERSON, USING SAME CREDIT CARD NUMBER, PLACED CALL TO DALLAS, TEXAS, FOR JACK RUBENSTEIN AND CALL WAS COMPLETED.

RECORDS OF DOGWOOD MOTEL, CHAMBLEE, GA., FOR MONTH OF NOVEMBER FAILED TO VERIFY STATEMENTS MADE BY TELEPHONE OPERATOR CONCERNING CALLS TO DALLAS AND NEW ORLEANS. RECORDS CHECKED SBTT, ATLANTA, GA., FOR CANCELLED CALLS ON NOVEMBER THREE, TEN AND SEVENTEEN PAREN SUNDAYS PAREN FAILED TO REVEAL ANY CANCELLED CARDS REFLECTING CALLS MENTIONED BY TELEPHONE OPERATOR.

[REDACTED] HAS APPROXIMATELY TWENTY YEARS EXPERIENCE WITH SBTT AND RESIDES WITH MOTHER AND WAS VERY EMOTIONAL CONCERNING

BACKGROUND

Referenced communications set forth information concerning alleged telephone calls made to subject and victim approximately three weeks previously by an unknown person using telephone credit card with number ending in 532.

On 11/27/63, [redacted] advised that telephone credit cards ending in the number 532 designate that the card has been issued in the Washington, D. C., corporate area (not including Maryland and Virginia). There are approximately 126,000 cards issued in this area. According to this source, no record of credit calls are maintained at the origin of the call and the charges are forwarded within a few days to the location where the card is issued for appropriate billing.
