[REDACTED] REINTERVIEWED AT ALBUQUERQUE THIS DATE. SHE
REAFFIRMED INFO PREVIOUSLY FURNISHED RE HOMOSEXUAL TENDENCIES OF RUBY.
HER ASSOCIATION WITH RUBY WAS FOR A PERIOD OF TWO WEEKS WHEN SHE
WAS STRIPPED AT THE CAROUSEL SOMETIME IN FIFTYSEVEN. SHE COULD NOT FURTHER
ELABORATE ON THE DATE. RUBY-S HOMOSEXUAL TENDENCIES WERE DISCUSSED
OPENLY BY PERSONNEL AT THE CAROUSEL AND AT THAT TIME RUBY HAD MALE
QUOTE GIRL FRIEND UNQUOTE WHOSE HOMOSEXUAL NAME WAS CARMEN. SHE DESCRIBE
CARMEN AS WH, TWENTYTWO YEARS, DARK BROWN CURLY HAIR, WHO PAINTED
HIS EYEBROWS AND DARKENED HIS EYE LASHES. [REDACTED] ONLY OBSERVED *b7d*
CARMEN AND RUBY TOGETHER ON THE STREETS AND AT THE CLUB. SHE STATED
RUBY TREATED CARMEN AS A TYPICAL FEMALE DATE, MAKING AFFECTIONATE
GESTURES TOWARD HIM WHEN HE LIGHTED CARMEN-S CIGARETTE OR GAVE HIM
A DRINK. SHE STATED CARMEN WAS A QUOTE FAGGOTT UNQUOTE THAT IS

EXTREMELY EFFEMINATE WHEN NOT IN RUBY-S PRESENCE, BUT CURBED THESE TENDENCIES WHEN IN RUBY-S PRESENCE. SHE STATED RUDY USED COLOGNE HEAVILY. STATES THAT THE ONLY OTHER PERSONNEL AT THE CLUB AT THAT TIME SHE CAN NOW RECALL WHO DISCUSSED MATTER WITH HER WAS A FEMALE PERSONNEL WHO DID A HALF AND HALF ACT BY THE NAME OF BRONYA /PHONETIC/. LAST NAME BELIEVED TO BE SIMILAR TO WARURN, WARBRUN OR VERBEN. BRONYA

WORKED FOR A MAN NAME BULLY WHO MAY HAVE BEEN FROM THE KANSAS CITY, MO., AREA, BUT SHE IS NOT SURE. DURING INTERVIEW, ██████████ REFERRED TO SUBJECT SEVERAL TIMES AS RUBY K. WHEN QUESTIONED CONCERNING THIS NAME, SHE SAID SHE AND OTHER PERSONNEL REFERRED TO RUBY WHEN NOT IN HIS PRESENCE AS RUBENKINS, A TERM OF ENDEARMENT AND RUBY K PROBABLY EVOLVED FROM THIS TERM. SHE STATED RUDY THREW CHAMPAGNE PARTIES AT THE CLUB AFTER CLOSING HOURS WHICH CARMEN WOULD ATTEND, HOWEVER, ██████████ WAS NEVER INVITED AND COULD FURNISH NO SPECIFIC INFO RE PARTIES. SHE COULD NOT RECALL EXACT DATES, TIMES OR ANY ASSOCIATES OF RUDY OTHER THAN THOSE SET FORTH ABOVE. FD THREE ZERO TWO FOLLOW.
