

He allegedly had cut his wrist during the night. She is suspicious of his sudden death since he was an apparently influential man. Only six people attended his funeral, a closed casket ceremony, three of whom were members of her family.

Her mother, who is now in her 80's and has had several strokes, resides at the Brookhaven Nursing Home, Farmers Branch, Texas, believed that really did not die and believes that he went to Israel to get away from the people that supposedly were after him.

was never questioned by any investigators after the assassination of President Kennedy, even though considered Ruby his best friend.
