In keeping with our well-established policy (one way-me to you) here is the little I've had time to add to the Compbell memos.

Two of the names 'not necessarily the same people' are in the Warren Commission files. These are Sam Williams and one James Troy Ivey, who need not be "Tiger Jim". This is what there is:

CB106:192, Samuel L Williams, as of 12/19/63, lived at 2008 Lanark Ave., Dallas/ the had worked for Eva Grant for a couple of weeks in February or march of 1963 and claimed to know nothing of Ruby's personal life, friends or acquaintences of of "no association between Ruby and Cawald".

CD104:22, James Troy Ivey, 1306 Bowie, Carland, as of 12/9/63, was interviewed because in Ruby's junk taken when he was arrested was a Carousel card in his name. He knew Ruby going back to 1952, when he serviced digarette vending machines. In 1958 Ivey became a deputy sheriff, after which he saw Ruby only a couple of times, in the sheriff's office. One of these, mid-October 1963, dealt with the complaint of a "girl entertainer" (naturally, unnamed) who claimed Ruby "had threatened to itempaterexistics burn her clothes' or something like that". Two weeks later Ruby saw Ivey again in the Sheriff's office, told him if he'd sign the card Ruby would return it, Ivey did, and never heard from Ruby again he also seas he has no personal knowledge of Ruby or any Ruby-Oswald relationship.

It would seem these are not the people in the Cempbell reports.

Now that the elections are over, you've had your vecation and all you have to do is take care of Hagerty, how about getting someone to duplicate copies of the transcripts (not Finck, Frazier or Nichols, which I have), three copies of each to take care of those who worked so hard to help me help you, and getting it done so we can carry it further.

Man, if you wanted snow, you shouldhave spent Christmes here. We still have it. Some of the reads are still single lane, with the cuts, after considerable thawing, as high as the top of the car. Where I dug my car out (which took me, in the full vigor of my years, only two days), there are still four-foot piles 25-30 feet long. We didn't get to use the car for eight days. I had gotten it 75% of the way down the lane when it simple froze in place when I pooped out and we had a thaw and then a freeze. It took two tractors, both slipping like hell, about 40 minutes to move it the ten feet that separated it from the cleared part of the lane. Old timey winter.

Hope im is making a good recovery and that the operation ends that problem. Best to you all.

Several weeks ago I sent you a list of names I had abstracted from some New Orleans interviews of people mentioned in connection with the training camp and other aspects. I also sent the erchives the same list. Yesterday I received a letter telling me they'd found a document under each of two names only, James Troy Ivey and Damuel Williams. I enclose copies. I do not have time to check and see whether these can be the identical people.

Paul, I also note I had asked for the memos from Specter's file re CD 498. This is the sentence, and again it may require careful reading for understanding:

"No letters or memorands relating to Commission Document 498 have been found in Arlen Specter's letter file". The Archives letter is dated 12/30/69, signed by Angel. I do not recall such letters or memos from my examination of that file, but that was in the summer of 1967, and my recall is not to be trusted. On the other hand, might I have missed its significance? When I consider what I was after, I doubt it. That was the beginning of the forcing out of some of the things I have since gotten.

WILLIAMS, 2008 Lanark Avenue, Dallas, Texas, advised he was employed by JACK RUBY's sister, EVA GRANT, as a porter at the Club Vegas in Dallas for about two weeks in February or March, 1963. He said he never worked for RUBY, he never met or saw RUBY at the Vegas Club, and he knows nothing about RUBY's personal life or business interests. Furthermore, he said he knew none of RUEY's friends or acquaintances. WILLIAMS also advised LEE HARVEY OSWALD was unknown to him and he knew of no association between RUBY and OSWALD.

JAMES TROY IVEY, 1306 Bowie, Garland, Texas, was interviewed in view of the fact that a Carousel Club card bearing his name was found in the possession of JACK RUBY at the time of his arrest. IVEY furnished the following information:

During 1952, he was employed as a route man for a cigarette vending company and in that capacity serviced the Silver Spur Club operated by JACK RUBY. He occasionally saw JACK RUBY when he serviced the cigarette machines; however, he had no association with RUBY other than RUBY being one of his customers. He saw RUBY occasionally until about 1957 when RUBY moved to the Vegas Club which was off of IVEY's route. During 1958, IVEY was appointed a Deputy Sheriff, Dallas County, and since that time he has seen RUBY two or three times in the Sheriff's Office. He did not talk to RUBY on these occasions. About the middle of October, 1963, RVBY and one of the girl entertainers at his club were in the Sheriff's Office. girl had complained that RUBY had threatened to "burn her clothes" or something like that and RVBY and this girl were discussing this matter with Justice of the Peace Judge RICHBERG. IVEY stated he did not follow this matter but is of the opinion it was probably sattled by the Judge at that time.

As RUBY was leaving the building, he spoke to IVEY and asked IVEY if he had seen the show at the Carousel Club and told IVEY that he would sent him a pass to the show.

IVEY continued that about two weeks later he came into the Sheriff's Office and saw RUEY talking to the office girl. When RUBY saw IVEY, he asked IVEY to sign the pass for the Carousel Club which IVEY signed as J. T. IVEY. RUBY said he would mail the card to him later. IVEY said he never did receive this card and thought nothing more about it.

IVEY stated he has only a speaking acquaintance; with RUBY and certainly does not consider RUBY to be a personal friend. He knows nothing concerning RUBY's associates, business dealings or any relations or connections RUBY might have with the Dallas Police Department. IVEY does not know THE MARVEY OSWALD and has no information as to whether there was ever any association between RUBY and OSWALD.
