I have read "Whitewash," and found it fascinating...truly has to be considered one of the seminal works on the assassination. Have not gotten to "Post Mortem" yet, but am looking forward to it...as I am looking forward to reading the above ordered books. I am going to try and build up my library...hope to one day find (and then be able to afford) the 26 volumes of hearings and testimony. Do you have any other books that you would recommend pursuing first? I would rather prioritize my efforts toward obtaining those books that will aid my understanding of the case the most. Any suggestions you can make will be most appreciated.

One book I made the mistake of buying was Jim Moore's "Conspiracy of One." I couldn't believe his arrogant, condescending tone toward you and the other "critics." I wrote to him in Waco and told him as much. I figured an ego like that would not/could not resist a personal challenge. Sure enough, he did respond at great length. His reply spurred me onto to launching another barrage of questions at him concerning his theories and "final solution." He again replied at length...but the old sarcasm and "holier-than-thou" attitude was beginning to show through again. As you would expect, he clung to his theories. I will write him one more time...but I grow tired of his attitude. I wrote to him with what I thought were pretty well-reasoned comments and questions...and for the most part he would just say "READ MY BOOK." I had hoped for amplification or clarification...and all I am getting now is regurgitation.

My point in all this is...have you read his book ? I assume you have. What did you think of it ? My major trouble with his work, was his documentation. The old cliché'...'he's lying and you're swearing to it,' comes to mind. It seems his book could've been written without ever having read the 26 volumes of hearings and testimony. He cites as his major sources the Warren and HSAC Reports themselves. In his entire book, he notes only 17 references from the 26 volumes of evidence...and only from 6 volumes at that.

I found it hard to believe that out of those thousands of pages and millions of words, that Moore could only find 17 instances that either backed up his assertions...or cast doubt on the findings of the "critics."


I don't mean to be a burden to you...I am just interested in any thoughts you had on this book.

I have just finished watching (and taping) the A & E Networks' showing of "The Men Who Killed Kennedy" in its "Investigative Reports" series. I found it extremely interesting. Thanks for your letter mailed 10/31. The only books we have are on our list. The only others I can recommend unstintingly are Sylvia Meagher's Accessories after the Fact and ~~Max~~ Howard Roffman's Presumed guilty. Both are superb and both, alas, long out of print.

Moore is not worthy of any consideration. His book is a palpable phony and I think he was seeking to commercialize the interest by taking the other side. "He is not ~~xxxx~~ worth wasting a postage stamp on. He can't give you "reassured comments. "

I've not looked at the Nigel Turner show on A & E. We do not have cable and I would not waste 5 hours on it. I saw the earlier version and that was too much with what he ^{he} ~~has~~ added, what he told me he'd not do otherwise I would not have agreed to be interviewed, pretend to solve the crime. So I can't make much other comment on it. It, too, is a commercialization and exploitation.

There have been no new factual developments. There is much nuttiness. And this includes the coming Oliver Stone movie, quite irresponsible and based on a fraudulent book puffed up by a compendium of all the nutty and unproven, usually untenable theories most of which are by people who have ~~not~~ bothered to learn the basic facts that are available. True of ^{or} ~~his~~ and his book in particular.

If you want a good JFK documentary get Gerard (Chip) Selby's Reasonable Doubt. It was his master's thesis and it won the highest honor in the CINE annual competition in the history division.
