I'm deep in FOIA/King matters, having spent yesterday afternoon with the FBI and left with a few new documents; have to go to New York for day beginning in early a.m.; and have to be infederal court in Washington Friday, so I'll answer your 3/22 in haste in order not to forget it. I udually do not know what the response to a broadcast is unless I take the mail in the days following. The way we work it when I'm writing is Idl kaes the records of orders first and then gives them to me to package. I generally do this during the evening TV news and do it mechanizally, paying no attention to where the orders go. I merely lick the labels she provides, unless as happens this time of the year, when she is deep in taxes, I go over and select out the non-commercial and institutional mail.

However, I'm sure we got some orders and I believe that with the 6-12 slot there would be a different audience and the possibility of getting more books around. The hour also is easier for me.

I've learned more about co-existing with this phlebitis and it makes doing a long show easier. When they take a break I do. I'm not supposed to sit more than 30 minutes without a little walking, to help the circulation. Merely walking the length of the hours and back is enough. Most of the shows I've been doing signee another doctor told me this have had a format which enabled them to tell me how long the break for a commercial would be, I'd lay down the phone for less time and walk, and then go until the next break. If Larry could do this that would be even better.

I've also reduced the discomfort and impairment of circulation by foam rubber. Under mt heels as I type now there is a 4-inch strip. Hanging on a magnetic hook on the end of my desk is a 2-inch piece large ebough to hold the right leg, all of it. So I sit by the phone with the right leg elevated higher, on the desk, and the left on the Yquem winde box with the heavier piece, and I'm in business. While I'd have liked to have had that kind of good wine, I'm grateful for the wooden box, which has been very helpful in my being able to keep my legs horizontal when I type.

I'm glad Larry Ford had a good reaction and liked the interview.

I'll be happ if he wants to do it again at a time that is no problem for me.

As of now I have to be away the night of the 5th and the early part of the week of the 18th only.
