Dear Vince,

Matt did not forward yout letter of the 14th until the 29th. It just reached me today. I've endorsed the check to the travel agent and will meil it with this. Thanks for that. I did check on what happened when I was in Washington. The fault is my own. They thought I planned to return during the full-rate period and had a tentative reservation for me on such a plane, hence could not use the excursion mate. I did not look at the ticket once I got it.

I will send you the file when I'm in New Orleans. Louis undoubtedly has it. Someone must have discovered it. I cannot take the time now to copy my own, for there is so much I have to do preparatory to going there. The way Moo is talking, they will want me more than a week before the trial. I wonder that no motions have been filed, especially because I think they now have a viable one. Perhaps they have to reach a policy determination.

In the course of checking out some of <sup>T</sup>hompson's inaccuracy for Moo, I had to go to the Archives. Having the time I continued some of my own temporarily abandoned work, with a high degree of success. If you recell what I told you about the executive sessions, I now have the missing link. I do not want to entrust it to the mails, so I'll have to be indirect. I gegard what ' now have, in my possession, as the most culpable single thing yet. Crucial evidence was destroyed. Not by accident, not by any possibility accidently, and not on any low-level exercise of authority.

By now <sup>G</sup>ary has probably told you what <sup>1</sup> had established on my temporary guest of that <sup>M</sup>onday morning. As I can, I am gathering more information. One of the two younger men involved has given me a good memo. I've asked him for further detail, specifying the areas in which I'vew more interest. I am waiting to hear from the second, to whom I've sent the same request, after hearing from him.

Well, we'll soon know what the new year holds. The best of it to you.
