Were it not that your note of the 6th requires response I'd ingore it and the enclosures as I did your previous mailing. To get to it first, we have to adjust to the realities and problems. If I were not already is low spirits I'd ingore was enclosures because you clearly have not even tried to separate yourself and your longings from your capabilities and limitations. In another effort to get you to confront all of this I'll be pretty blunt.

What has me on a temporary downer is a combination ranging from what you observed seven or more years ago and didn't trouble to tell me, letting it deteriorate seriously to the point where probably nothing can be done to my physicial and financial handicaps at just the moment I need activity and mobility to the utterly insane campaign of which, despite your assurance of not long ago that your really are and have been out of it.

You people, without exception, a political infants and ego-trippers whomcan't restrain childish and immature and ill-considered impulses to do good in the one way that can't. You could not have been more Schewiker's worst enemy than in dumping that effluvia on him. You and others combined in this as soon as I a) got his feet on the ground and b) was then hospitalized.

If you think that the garbage you refer to has any chance of doing anything other than hurting, more if he makes an effort to use it, crawl back into a womb. The would and the information gathered by others while those of you with this great ambition were improving your personal positions have advanced far. For you to intrude that stuff that didn't stack eight years ago now if to be an enemy ofmtruth and succe ss. It was good to talk with you on the phone last week. I have been too busy to write. I got a call yesterday from Senator Schweiker and David Marston and will be sending them some information too. I will try to send items to either you or Mr. Marston, not to both, knowing that you are in touch and wanting to avoid duplication.

I will get you those documents on James W. Powell, the Army Intelligence man who photographed events in Dealy Plaza and who was found inside the Book Depository Bldg. by the Secret Service. We have been unable to find him through amateurish methods. There were a number of James Powells in Dallas in 1963, and two James W. Powell

I suggest that you examine Commission Exhibit 1024 in the 26 volumes. It is the report of Secret Service Agent Berger about an unusual incident that occurred outside Trauma Room 1 in the Parkland Hospital. A man claiming to be an FBI agent had to be forcibly prevented from entering by the alert Secret Service Agent. Congressman Olin Teague witnessed this incident. I have not been able to locate further information on this incident. Was this guy an FBI agent and if so, what was he up to?

Enclosed is a copy of a letter from someone who served time in the Federal Prison and Hospital at Springfield, Illinois. A newspaper clipping is attached which pertains to the man sending the letter to give you some background on him. He is a reliable person. The main subject of his letter is Secret Service agent Abraham Bolden who claimed after the assassination that the President had not been properly protected. The Warren Commission never had him interviewed and he ended up imprison for allegedly taking a bribe. There is some evidence he was framed for this. This is probably peripheral to what you are investigating, but I can get you more information if you want to pursue it.
