Dear Harold,

Thanks for your letter of Sept. 30.

The article will focus on the fallacy of the conspiracy to kill witnesses suggested by many, refute the numbers argument of the London Times, but emphasize that many have been threatened and a few deaths are suspicious, and above all point out that every year of delay means more people die or are killed and so fewer are around to be re-interviewed.

But, you are right. I am out of the case and the best I can do is refer interested parties to people who are more active.
