Sex Article Brings More Victims Out of Closet

The staff of our center was very pleased with Ingrid Sundstrom's article on "Sex and the Therapist" (Oc-

Ingrid spent considerable time with members of our staff while preparing the article and we now feel that this time was well spent. This is a tricky issue which must be discussed with great care if one is not to distort things by sensationalizing. All of us were pleased with the accurate quotes attributed to us, especially given how touchy this subject is among professionals.

Your decision to publish such an article was very commendable. The medium of the popular magazine is one of the most ideal for a discussion of issues related to protection of the consumer-in this case the consumer of a professional service. Other than reports on occasional professional debates on this topic, or Vogue's report on a book on the topic, no popular magazine to my knowledge has published such a consumer-oriented piece.

Already the article has had some important positive effects. One woman called our center to discuss some continuing concerns about a sexual involvement with a therapist. Another came in for help in pursuing a complaint against a therapist who had sexually exploited her. It is our hope that still others will realize that such involvements are shunned by responsible professionals and that help is available for those who have suffered. It is also our hope that growing assertiveness on the part of consumers of professional psychotherapy will help more people pull out of therapeutic relationships which are becoming destructive earlier. Perhaps more people, realizing that such behavior is unethical, will file complaints so as to prevent others from facing the same exploitation.

Thanks again to Ingrid and Mpls. Magazine for bringing this timely issue to the fore.
