Dear Harold,

I was down here on Saturday to be interviewed by a Canadian TV station about abuse by doctors and so thought I'd whip off a letter to you.

It was good to hear from you. I thought of phoning when I got the notice of Bud's death.

Sorry to hear about Lil's and your health problems.

Alex and Katherine and I have been doing OK. He continues to grow and develop, although he's still behind other kids his age (nearly 3 1/2 yrs. old now). The physical and speech therapy is helping and we've decided that he isn't going to catch up quickly. On the other side, he's a happy and healthy boy who's a great joy to be with, so we don't have the problems some other parents do.

I was distress to hear about the Stone movie, wondering what sort of theories he was following. I haven't actually seen Garrison's book ON THE TRAIL OF ASSASSINS.

I don't know where my Rose/McNabb file is, but I remember the story completely, so here it goes:

After a presentation I gave in somebody's home, in which I made passing mention of Richard Case Nagell, a young woman came up and said that she knew something about him. That when she and another (typical naive midwestern Lutheran) were in Mexico City, a friendly American bought them drinks. He said he was an orphan, that he used to fly for the CIA, that he was from Miami, and he asked them to take a message to Nagell. He had Nagell's prisoner number and knew he was in Leavenworth (remember that we all thought he was still in Springfield, which is where Kroman ended up in the next cell--Kroman was, I'm convinced, investigating Abraham Bolden, and he brought out phoney info from Bolden, that Fran Galt, also a prisoner and war resister, set straight later).

When Hal Verb and I were visiting you and went to the Archives that time we went ~~through~~ through all those documents for nearly a week, Hal and I were comparing notes and I told him the story from the girls. A light went on, and he said that he'd heard of, or met, a Vince or Jim Rose, ex-CIA pilot from Miami, also an orphan! He wondered if they could be the same, and we set out to get a photo of Rose without tipping anyone off as to why. That's when Bill Turner came in and vouched from Rose. Rose later admitted he was the guy in Mexico. That was then the basis for questioning Turner, since he lied for Rose, not knowing that we knew other stuff. Kroman, by the way, gave a phoney description of ~~McNabb~~ "McNabb" and then got very agitated when I confronted him about it and he realized that I might know his real description.
