
Re Dallas teletype to Bureau and New York 9/9/64, concerning telephone call from New York to Dallas Chief of Police JESSE E. CURRY

On 9/9/64, inquiry at New York Telephone Company, New York City, disclosed that phone number EM 2-1006 is registered to Hotel Milburn, 241 Mest 76th Street, New York City.

On 9/9/64, a review of MTO indices re CARL Schreiber reflected that elosed MT 105-0-10581 indicates that an 1/1/61, one CARL SCHREIBER, 185 West 86th Street, Mew York City, telephonically contacted the New York Office and requested that an agent of the MTO discreetly contact him at the above address in order that SCHREIBER may furnish information in his possession re activities in the Dominican Republic. Subsequently, an agent of the NTO attempted to contact SCHREIBER at the above address, which is a hotel, but SCHREIBER and moved without leaving a forwarding address.

On 9/10/64, M. KAIN, Manager, Hotel Milburn, 243 West 76th Street, New York City, advised SA JOHN JAMES O'FLAHERTY that hotel records reflect that CARL SCHREIBER registered at the hotel on 8/21/64, and presently occupies room 11F. A previous address for SCHREIBER was indicated as Box 800, Los Alamos, N.M. KAIN stated he does not know SCHREIBER personally and could only advise that SCHREIBER is about 48 years of age. He was unable to furnish any additional descriptive data on employment concerning SCHREIBER.

In an effort to determine if CARL SCHREIBER referred to in New York file 105-0-10581 may possibly be identical with CARL SCHREBER referred to in retel, the following inquiry was conducteds

On 9/10/64, SIMON CHERN, Manager, Motel Dexter
House, 345 West 86th Street, New York City, advised SA JOHN
JAMES O'PLAHERTY that CARL SCHREIBER, white, male, 45-50 years
of age, approximately 5'10", stocky build, although not
presently at the Hotel Dexter, has in the past, periodically
resided there on numerous occasions. CHERN stated that
1961 registration card reflected a previous address as 305
206, Alamogordo, N.M.

CHERN remarked that he personally knows SCHREIMER and stated that SCHREIMER is a World War II disabled the personal who receives disability checks from the Government. He stated that SCHREIMER was a captain and pilot in the United States Air Force and as a result of a head injury roveived in combat, he has a metal plate in his head. CWER' advised that whenever SCHREIMER's head injury causes pain, SCHREIMER drinks to excess and quite often, while in an intoxicated state has a profession of waking numerous phone calls. CENTER AND THE THE UNITED WARREST THE UNKNOWN, Who resides in New Mexico and reportedly occupied some political position in that area. CWERN remarked that one occasion, while apparently intoxicated, SCHREIMER placed a call through the hotel switchboard to New York

Governor ROCKEFELLER.

CWERN added that SCHREIBER is an attorney and reportedly was a candidate, on one occasion, for the office of District Attorney somewhere in the New Mexico area. He further stated that on one occasion SCHREIBER displayed to him a letter which SCHREIBER stated was a letter indicating that consideration was being given to appointing SCHREIBER as Commissioner of the New York State Thruway. CWERN was of the opinion that due to SCHREIBER's disability he never received the appointment.

In view of the above, it would appear that the CARL SCHREIBER referred to by CWERN is probably identical with the CARL SCHREIBER who contacted the New York Office on 3/1/63, from the Hotel Dexter House and also identical with the CARL SCHREIBER referred to in retel.
