The signature at the beginning is to keep my from forgetting again. But my typing is so terrible it is a signature!

I knew Arthur had a foundation more than a year ago. I knew of the Price Foundation when the foundation-CIA story broke a long time ago. I know of no other Price Foundation than his. So maybe it is all one. If it is, it doesn't worry me. I worked with the genuine articles for some time.

To answer your ~~xxxxxxxxxxxx~~ letter (I've very tired) in haste: I imagine I am responsible for the Shaw-Bertrend statement by the NY. And it had get used by some newspapers. I have the Wash Post and the N.O. papers stories. I say all of this and much more in my N.O. book, that for the first time is now going around among the publishing houses. I can trace Hoover's statement of 11/24/66 to a similar thing. He then answer charges from my unpublished work, charges I had never made publicly. It is quite true there was no Shaw investigation. "one was needed. I point out there could have been none without his knowledge. This just makes a bigger mess for them. They improvise their lies, which is not very wise. Maybe there will be a few more soon. I'm glad to get the extra copy of Semple's article, which I have. I drove him from the Archives to the NYTimes Wash office about that time. The NY later also confirmed this to the Wash Post, which I quoted in the book because I had mislead theTimes clip.

It was not before Clark's appointment but after. He was questioned as he left the Sen Jud Com hearing on his nomination.

When CIA WHITEWASH is published you'll see more on this. It is not often that the integrity of a cabinet officer is vested in a lie. Note nothing has happened to the one who "misinforme" him.

Interesting Arthur wants to talk <sup>to</sup> me <sup>about</sup> his beard. I'd never asked it. He had suggested, as you did, that I organize a foundation, which is not the same thing. He is going to establish an unofficial Kennedy archive. I'm all for that.

Several things in your attachment interest, esp. items 5 (sources). Wash Star hates Johnson, but not some of his policies.

I've almost finished PHOTOGRAPHIC WHITEWASH, very tired, and must rush it. This is part of the answer to your last question,

Dear Harold:

Certainly very good to receive your letter of 5/27/67, and although unsigned, I knew immediately that it was you. Likewise, I won't sign this letter but I imagine you will gather that it is I.

I am enclosing a few items which I'm sure you don't know about; at any rate, I'd like you to take the time to try some of them for size. Or, as they say, Run it up the flag-pole and let's see if anybody salutes it. Or something.

As you may know there was a WOR Radio news-report on the John Wingate Program June 2, 1967 at 8PM: the FBI today stated Attorney General Ramsey Clark was in error when Clark said on March 2/67 (NYTIMES March 3) that Clay Shaw "was involved in an FBI investigation in the New Orleans area in November and December, 1963. We have the evidence that's there involved, and you can assume that the FBI's conclusions were from the Warren ~~Report~~ Commission Report." (sic)

The John Wingate news item was almost electrifying to me, Harold, because I had just been reading the March 3 Ramsey Clark statement in the Times. The radio news item went on to say that the FBI never investigated Shaw and that the FBI never heard of him before the Garrison investigation.

I couldn't find one word about this WOR June 2 news-flash in any of the newspapers since then; and I think it is very interesting that the head of the U.S. Dept. of Justice, Clark, should say that he knows Shaw was thoroughly investigated by the FBI, and, then the FBI denies that it ever investigated Shaw. And, the media doesn't print one word, here in NYC about it. Robert B. Semple, Jr. is the Reporter in the March 2/67 Special to the New York Times.

I can't comment about Price; I just sense something there; particularly when he inquired about your detailed background in order to present these details to his close friends who are members of the Board of Directors of the very Foundations mentioned at the time of the CIA-Foundation affiliation disclosures. I'm probably wrong about this; perhaps Price doesn't read the news; I reminded him that probably Weisberg and Lane and anyone else ~~would be~~ would be highly interesting to a Foundation affiliated with CIA money, and, Price said: Of course, not. This was by phone; he called me back a few days later, tentative future appt., and I haven't contacted him since. Anyway, I don't know your detailed background and I told him to call you about that. Who knows.

THE INVOLVMENT OF LYNDON JOHNSON IN THE  
MURDER OF PRESIDENT JOHN F. KENNEDY

1. WALTER JENKINS, CHIEF AIDE TO LYNDON JOHNSON FOR MANY YEARS, WAS FORCED TO RESIGN DURING THE 1964 JOHNSON-GOLDWATER PRESIDENTIAL CAMPAIGN. JENKINS' CRIMINAL RECORD AS A HOMOSEXUAL-PERVERT WAS EXPOSED; THE WASHINGTON D.C. POLICE HAD ARRESTED JENKINS A NUMBER OF TIMES FOR HOMOSEXUALITY IN THE LOCAL YMCA TOILET.
2. J. EDGAR HOOVER SENT A BOUQUET OF FLOWERS AND LOYALTY-NOTE TO JENKINS WHEN JENKINS RESIGNED AND ENTERED THE HOSPITAL AT WASHINGTON; THE 71 YEAR-OLD BACHELOR HEAD OF THE FBI HAD BEEN A CLOSE FRIEND OF WALTER JENKINS. IN FACT, HOOVER WAS ALSO A VERY CLOSE FRIEND OF JENKINS' BROTHER, AN FBI AGENT ASSIGNED TO THE DALLAS AND TEXAS AREA FOR MORE THAN 25 YEARS.
3. WALTER JENKINS' BROTHER HAD BEEN ASSIGNED TO SENSITIVE SECURITY JOBS IN THE SOUTHWEST BY HOOVER; AND HENRY WADE, THE DISTRICT ATTORNEY OF DALLAS AT THE TIME OF THE ASSASSINATION OF JOHN F. KENNEDY WAS A CLOSE FRIEND OF HOOVER, JENKINS AND LYNDON JOHNSON.
4. CLAY SHAW (CALLED CLAY OR CLEM BERTRAND) IN THE WARREN REPORT, IS A CLOSE FRIEND OF WALTER JENKINS; CLAY SHAW IS ALSO PERSONALLY KNOWN TO J. EDGAR HOOVER AND LYNDON JOHNSON.
5. CLAY SHAW IS A KNOWN HOMOSEXUAL IN NEW ORLEANS, SAN FRANCISCO AND ELSEWHERE INCLUDING NEW YORK CITY. CLAY SHAW IS THE FORMER BUSINESS-MAN IN CHARGE OF THE NEW ORLEANS TRADE MART; CLAY SHAW HAD HIS OFFICE IN THE TRADE MART BUILDING DURING THE SUMMER OF 1963.
6. IT WAS IN FRONT OF THE TRADE MART BUILDING DURING THE SUMMER OF 1963 THAT LEE OSWALD DISTRIBUTED "FAIR PLAY FOR CUBA" LEAFLETS FOR THE BENEFIT OF PHOTOGRAPHERS WHOSE PICTURES APPEAR IN THE WARREN REPORT. ALL PHOTOGRAPHS OF OSWALD IN NEW ORLEANS DISTRIBUTING CUBA LEAFLETS ARE TAKEN IN FRONT OF THE TRADE MART BUILDING WHILE CLAY SHAW WAS UPSTAIRS IN THAT BUILDING.
7. LYNDON JOHNSON TELEPHONED WALTER JENKINS FROM THE PLANE AT LOVE FIELD IN DALLAS ON NOVEMBER 22; IT WAS THE FIRST CALL JOHNSON MADE AFTER HE KNEW KENNEDY WAS DEAD. JOHNSON TOLD JENKINS WHO WAS IN WASHINGTON THAT "EVERYTHING O.K.". THE PRESS REPORTED THE EFFICIENCY WITH WHICH WALTER JENKINS IMMEDIATELY COORDINATED THE ASSUMPTION OF POWER ON BEHALF OF THE NEW PRESIDENT. THE SMOOTHNESS WAS CONSIDERED BY THE PRESS TO BE REMARKABLE IN THE LIGHT OF THE CATAclysmic TRAGEDY.
8. MUCH LATER, IN MARCH, 1967, A NUMBER OF AMERICAN JOURNALISTS WERE PUZZLED BY CERTAIN QUICK MOVEMENTS OF LYNDON JOHNSON AND ONE OR TWO OF THOSE JOURNALISTS MADE A POINT OF RELATIONSHIP. FOR INSTANCE, UPON THE VERY NIGHT BEFORE CLAY SHAW WAS INDICTED FOR CONSPIRACY LYNDON JOHNSON FLEW TO GUAM FOR CONFERENCE WITH PREMIER KY AND OTHER LEADERS IN THE VIETNAM WAR. THE WORLD HEADLINES CARRIED THE GUAM CONFERENCE AND THE INDICTMENT OF CLAY SHAW FOR CONSPIRACY TO MURDER PRESIDENT KENNEDY WAS IGNORED OR CARRIED ONLY ON THE BACK PAGES. PREMIER KY, ARRIVING GUAM AT THE ABRUPT CONFERENCE, MADE STATEMENTS TO THE PRESS WHICH HE LATER CHANGED AFTER CONFERRING WITH JOHNSON; KY EXPLAINED TO THE PRESS THAT HE WAS MISUNDERSTOOD UPON ARRIVAL BUT THAT AFTER SPEAKING WITH JOHNSON KY DESIRED TO BE REQUOTED.
9. THE NEW ORLEANS' COURT STATED THAT CLAY SHAW WAS INDICTED FOR THE FELONY OF CONSPIRACY TO MURDER PRESIDENT KENNEDY; CLAY SHAW'S TRIAL WOULD TAKE PLACE WITHIN 6 MONTHS OF THE INDICTMENT. AT GUAM, LYNDON JOHNSON ANNOUNCED THAT "ANOTHER GUAM CONFERENCE MAY BE NECESSARY WITHIN 6 MONTHS."
10. THE WASHINGTON (DC) STAR, A NEWSPAPER WHICH GENERALLY SUPPORTS JOHNSON SAID: "If there is any necessary or even good reason for President Johnson's long and somewhat risky flight to Guam, it does not appear on the face of anything that has been published or said about that get-together."

11. THE CAREERS OF LYNDON JOHNSON AND WALTER JENKINS IN TEXAS POLITICS ARE MARKED BY THE QUESTIONS OF EXACTLY, JUST WHERE DID WALTER JENKINS AND LYNDON JOHNSON MEET ONE ANOTHER? AND, EXACTLY WHAT WAS THE EXPERIENCE WITH THE POLICE AND OTHER AUTHORITIES WHICH LYNDON JOHNSON HAD WHEN HE LEFT TEXAS FOR CALIFORNIA IN THE EARLY 1930's? IT IS POSSIBLE THAT THE POLITICAL-HARDNESS WHICH LYNDON JOHNSON UTILIZES IS NOTHING MORE THAN THE EX-JAILBIRD COLDLY APPRAISING AND EXECUTING A CRIMINAL PLAN; CERTAINLY, THAT PERIOD OF LYNDON JOHNSON'S LIFE DURING 1929-1932 SHOULD BE CLOSELY INVESTIGATED. IT MAY EXPLAIN THE CANDID MOVEMENT OF HIS FINGER TOWARD THE NUCLEAR BUTTON IN TIME OF CRISES.

12. AFTER CERTAIN REMARKABLE STATEMENTS BY RAMSEY CLARK IN MARCH OF 1967, CLARK WAS APPOINTED ATTORNEY GENERAL OF THE UNITED STATES BY LYNDON JOHNSON. IT SHOULD BE NOTED THAT BEFORE RAMSEY CLARK WAS SWORN IN AS ATTORNEY GENERAL OF THE UNITED STATES HE SAID:

CLAY SHAW "was involved in an FBI investigation in the New Orleans area in November and December, 1963. We have the evidence that's there involved, and you can assume that their conclusions were from the Warren Commission Report."

THIS GOBBELYDECOCK, BY RAMSEY CLARK, MEANS THAT CLAY SHAW WAS CHECKED OUT BY THE FBI AND THERE WAS NO CONNECTION FOUND BY THE FBI BETWEEN OSWALD AND CLAY SHAW.

RAMSEY CLARK WAS THEN APPOINTED ATTORNEY GENERAL OF THE UNITED STATES BY LYNDON JOHNSON.

RAMSEY CLARK WAS BORN IN DALLAS, REARED IN DALLAS, PRACTISED LAW IN DALLAS AND SO WAS HIS FATHER, JUSTICE TOM CLARK. AND THAT IS A CABAL IN ANY LANGUAGE PARTICULARLY IN THE LIGHT OF A NEWS-FLASH ON RADIO WOR IN NEW YORK CITY AT 8:05 PM JUNE 2, 1967, JOHN WINGATE SAYING: THE FBI TODAY STATED RAMSEY CLARK IN ERROR ABOUT FBI KNOWLEDGE OF CLAY SHAW. THE FBI NEVER HEARD OF CLAY L. SHAW DURING THE INVESTIGATION OF THE ASSASSINATION OF PRESIDENT KENNEDY. THE FBI NEVER INVESTIGATED SHAW.

NO NEWSPAPER HERE IN NEW YORK CITY OR ANYWHERE ELSE CARRIED THIS UTTERLY FANTASTIC FBI STATEMENT THAT CLAY L. SHAW HAD NOT BEEN INVESTIGATED. YET, RAMSEY CLARK WAS APPOINTED ATTORNEY GENERAL OF THE UNITED STATES BY LYNDON JOHNSON IMMEDIATELY AFTER CLARK SAID THAT CLAY SHAW HAD BEEN INVESTIGATED BY THE FBI. HE WAS CHECKED OUT AND FOUND CLEAR, SAID ACTING ATTORNEY GENERAL CLARK.

13. THE WRIT OF HABEAS CORPUS IS SUSPENDED WHEN THE CONGRESS OF THE UNITED STATES VOTES " A STATE OF WAR". THE CONSTITUTION PROVIDES THAT ANY PERSON MAY BE ARRESTED AND DETAINED WITHOUT A HEARING DURING TIME OF WAR.

THIS MEANS THAT THE ATTORNEY GENERAL OF THE UNITED STATES BY FIAT CAN ARREST AND DETAIN WITHOUT COURT HEARING ANY AND ALL PERSONS IN THE UNITED STATES. THE ATTORNEY GENERAL MAY USE THE ARMED FORCES TO SUPPRESS FEDERAL AND STATE JUDGES, AND ALL POLICE OFFICERS WITHIN THE UNITED STATES. IN TIME OF WAR, IMMEDIATE REVIEW BY HABEAS CORPUS BEFORE THE COURTS IS SUSPENDED.

ANY PERSON WITHIN THE UNITED STATES OR ITS TERRITORIES MAY BE SEIZED AND DETAINED WITHOUT RIGHT TO A HEARING IN TIME OF WAR. LYNDON JOHNSON SEEKS A DECLARATION OF " A STATE OF WAR".
