(2) It is an election-year; Harold, you cannot relegate people like Jack Kennedy to a Bowery-Bum's interment.

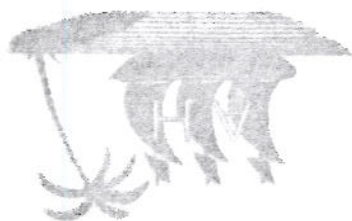
(Incidentally, Harold, (and forgive me for asking, but just how do you know how a Bowery-Bum is treated, interred, and buried?))

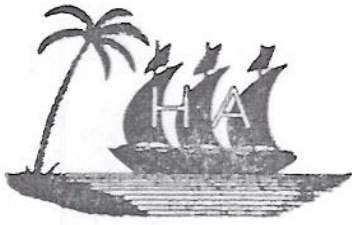
