(ZNS) VETERAN ASSASSINATION RESEARCHER HAROLD WEISBERG IS CHARGING THAT THE RECENTLY-RELEASED REPORT ON PRESIDENT KENNEDY'S ASSASSINATION HAS BEEN SPECIALLY TAILORED TO PROTECT THE POLITICAL FUTURE OF PRESIDENT GERALD FORD.

WEISBERG, A LONGTIME CRITIC OF BOTH THE F.B.I. AND THE C.I.A., CLAIMS THE SO-CALLED "SCHWEIKER COMMITTEE REPORT" UNFAIRLY BLAMES THE TWO AGENCIES WHILE COMPLETELY PROTECTING THE WARREN COMMISSION.

THE REPORT, SUBMITTED BY SENATOR RICHARD SCHWEIKER, CONCLUDES THERE WAS A PROBABLE "COVER-UP" IN THE 1964 INVESTIGATION INTO PRESIDENT KENNEDY'S MURDER. THE REPORT ACCUSES THE F.B.I. AND C.I.A. OF WITHHOLDING IMPORTANT EVIDENCE FROM THE WARREN COMMISSION WITHOUT THE COMMISSION'S KNOWLEDGE.

WEISBERG, HOWEVER, CITES COMMISSION DOCUMENTS WHICH HE SAYS PROVE THAT MEMBERS OF THE WARREN COMMISSION KNEW THEY WERE NOT GETTING FULL INFORMATION FROM THE F.B.I. AND THE C.I.A.

ONE DOCUMENT, HE SAYS, IS A RECENTLY-RELEASED TRANSCRIPT OF A 1964 CLOSED-DOOR MEETING OF THE SEVEN WARREN COMMISSIONERS, INCLUDING THEN CONGRESSMAN GERALD FORD. DURING THAT MEETING, THE SEVEN COMMISSIONERS TALKED ABOUT A POSSIBLE COVER-UP OF LEADS BY THE F.B.I., OF A POSSIBLE CONSPIRACY INVOLVING LEE HARVEY OSWALD, AND OF THE POSSIBILITY THAT OSWALD MAY HAVE BEEN AN UNDERCOVER U.S. INTELLIGENCE AGENT.

THE TRANSCRIPT EVEN SHOWS THAT THE SEVEN COMMISSIONERS REQUESTED THAT THE RECORD OF THE MEETING BE DESTROYED AT THE CONCLUSION OF THE SESSION.

WEISBERG CHARGES THAT THE SENATE REPORT AVOIDS LINKING THE WARREN COMMISSION TO ANY COVER-UP BECAUSE FORD, A COMMISSION MEMBER, COULD BE BADLY HURT POLITICALLY -- ZODIAC
