Mr. Harold Weisberg, (re: Frederick, Maryland):

Let me say that this note is 30 years overdue! I am sorry. Let us hope you live to be 100 - or more - we need you to carry on! I can recall your TV appearances on WJZ-TV's "Contact AM," with John Sterling & Bill Gylward from 1964 - 1970. That was long ago - but JFK & the Warren Com. Report were the issues. Oh I can remember it all! (Ditto, David Susskind & Merv Griffin & Les Crane). How we lived to talk about JFK! Then, silence. I never forgot. Can we ever forget this? No!

It is good that you received the FOIA. There may be several more. I will send you data from time to time. (Finck, etc., AFIP, Institute of Pathology).

I hope you have good locks & security. I do not trust anyone on this. Keep very confidential.

I fear for Oliver Stone & Dr. Charles Crenshaw. They may be in danger. Me too! You too! Who knows?

Let me state: (Additional Xerox cover letter from the recent FOIA is enclosed for you. Data also from Jim Lesar, D.C. Assassination Archives.)

There is so much to say, to do, to transmit here:

- ① I am former DOD employee. I work now for U.S. National Archives. (Do not repeat or transmit!)
- ② I told no one anything at the U.S. National Archives
- ③ I committed no crimes. I learned of crimes at DOD.

- ④ I learned of "crimes" or wrongdoing in 1985, 1986. I was shocked, but kept quiet. I did not become concerned until I saw the "JFK" movie, and then read Dr. Crenshaw's book. I am concerned now! That is why I asked DOD for the FOIA (several) to verify the narratives & many rumors & stories. My relatives have received now these "threatening" phone calls. I am "unlisted." They are annoyed at me? I committed no crimes. I signed no statements of non-disclosure. They made others do that. Who is making these telephone calls? Who is annoyed at me?
- ⑤ In great confidence, I relay to you: that Ms. Joan Schilling (and) Mr. Ken Vrtacnik changed the JFK autopsy photos, with the orders of "alleged" FBI agents, and they all (several others) signed statements of non-disclosure with the FBI. Both Ms. Schilling & Mr. Vrtacnik (VRA-TAN-NIK) told me so.
- ⑥ Mr. Vrtacnik also stood CQ sentry duty over President Kennedy's brain tissue. He told me so. I told all of this to Jim Lesar at the Assassination Archives, D.C. I did not tell the National Archives. Do not repeat!
- ⑦ I need the FOIA on Vrtacnik & Schilling. Can you help? I need a "blind cover" to hide behind. I am afraid! Am I wrong? Huh???
