I have no reason to believe that Oswald had in mind yeth an escape as you indicate, as to Cuba or KANANA Louisiana. I think he went to the theater just not to be seen.

JUST KEEPING IN TOUCH, GOSSIP, ETC. FOR YOUR INFO, MR. STEVE TILLEY, NATIONAL ARCHIVES, WASH., D.C. & COLLEGE PARK, MD., IS NOW HEAD AND CHIEF AND LIAISON FOR JFK ASSASSINATION ARCHIVE. JUST BETWEEN ME AND YOU, I WOULD SAY THAT HE IS ALERT AND WELL-VERSED, BUT HE DOES NOT KNOW ALL AREAS OF BACK-GROUND INFO AND TRIVIA. HE SAYS THAT, "THE ARCHIVES NEVER HAD THE PRESIDENT'S BRAIN OR BRAIN MATTER," THUS, "WE NEVER LOST IT." NOW, I CAN TELL YOU, MR.
