Some. On the committee I'd ask Tom Kelley, S.S., 1800 G MW. I think the Secret Service made such a list and I know they had someone keeping close track of their records and what was dene with them.

By now Archives should have one. I'd ask Johnson.

Bud had one made years ago. He mineographed it.

I may have it if you want it. I think he or I sent Boch a copy and perhaps Boch had a similar list. As I recall there were some serrors in Bud's.

You may have the answer by now. If not suggest that on the unofficial level you begin with the nice girl who is helping Bud and whose name escapes me. Beth.

Saltsman in Schnectady might be a good source.

On this kind of thing I'd regard Eoch as the most absolutily solid. I had long doubts a bout his judgement in many areas but not about his record-keeping or the filigence of his records searching.

It seems to me there was also a list bracketing CDs and CEs that might be of help to you. You did not ask.

There are also duplicating CBs where the records are not identical. I recall one from Oswald in New Orleans. ou had better learn if you have not that this is common with internal agency records. I recall some FBI examples.

If you do not know I have broken any relations with your committee. I believe this was required of me by reasons you are welcome to if you want them. This has nothing to do with you personally. There may be occasions of which it need give me no problems in some areas of the committee's researches. If there are such occasions I will take each one separately. I am reminded by this by 0 in N.O. The 544 Camp Bldg. has been destroyed. I have pictures of both exterior walls and the building itself from several positions in lafayette fark. I did do some investigating of that business. I am not now prepared to share the investigation with the committee but if in the future it needs these pictures I'd probably lend them. If you go into that Douglas Jones is dead. He died in Hurricane Camille. I interviewed him twice, once on tape. His place also was torn down.

My forgetting was not on purpose. I hurt a tendon in my right arm. It limited me until now and I'm catching up.

Dear Mr. Rankin:

There are forwarded herewith copies of reports from the Secret Service files relative to the assassination of President Kennedy.

A list identifying the reports by SS control numbers is attached.

Our files contain a number of documents classified as SECRET and identified by Secret Service control numbers 157, 161, 162, 163, 164, 165, 166, 171, 172, 174, and 403. Since these were received from other agencies, they cannot be released by us. I suggest that a member of the Commission's staff, holding the proper security clearance, review these documents in our files and determine which ones the Commission considers pertinent. Requests can then be made of the submitting agency for copies.

As indicated in my letter of January 6, 1964, the remaining files of the Secret Service are available for review by your staff for the purpose of extracting any additional reports or information contained therein. The attached reports were selected as being, in our judgment, information of paramount interest to the Commission at this time.

The enclosures also include a group of still photographs reconstructing the assassination scene, including photographs taken through a telescopic lens.

Reports submitted subsequent to our review of the files on January 6, 1964, will be forwarded to you periodically.
