**SYNOPSIS**

Lee Harvey Oswald sailed from New Orleans on September 20, 1959, on the SS Marion Lykes, as a passenger, and arrived LaHavre, France, on October 3, 1959. No information developed as to mode of travel from France to Russia. Oswald was placed in the Bethlehem Childrens Home, New Orleans, on 12/26/42 and remained there until January, 1944.

DETAILS OF INVESTIGATION

Reference is made to my report dated 12/28/63, in the above captioned case.

On 12/30/63 Mr. H. G. Maynor, Special Agent in Charge, Federal Bureau of Investigation, New Orleans, informed me that their investigation disclosed that Lee Harvey Oswald sailed from New Orleans on September 20, 1959, on the SS Marion Lykes, arriving at LaHavre, France, on October 8, 1959. No information was available as to the mode of transportation from France to Russia, or the dates involved.

Mr. Maynor was requested to determine if Oswald was a passenger or a crewman on the SS Marion Lykes. He was also requested to inform me of the particulars with reference to Oswald's stay at the Bethlehem Childrens Home in New Orleans. He stated that his reports would be reviewed and this information furnished at a later date.

On 1/3/64 Mr. Joseph Sylvester, Assistant Special Agent in Charge, Federal Bureau of Investigation, informed me that Oswald was a passenger on the SS Marion Lykes. He further advised that Oswald was placed in the Bethlehem Childrens Home, 9100 Grant Street, New Orleans, on 12/26/42, and that he remained there until January, 1944, exact date undetermined. The home in question is operated by the Lutheran Church.
