or that there is, which I doubt with an unlisted phone.

If this turns out to be any kind of violation of local law and the author-
ities there are interested, maybe I can help because this does smack of something
of which I have known for a while and it is fraudulent.

DEAR MR WEISBERG,

I TALKED TO A MR. JIM CAROLLA, A NEWSMAN FOR KILT RADIO, THIS MORNING. HE IS THE NEWSMAN WHO MADE THE INTERVIEW I DISCUSSED WITH YOU ON THE PHONE LAST NIGHT.

HE WAS VERY COOPERATIVE, AND STATED THAT THE GENTLEMAN HE SPOKE WITH WAS A "MR PEPPER CROWDER." THIS GENTLEMAN WORKS DIRECTLY FOR "MR. DAVID SALMON" WHO EITHER OWNS, OR IS IN CHARGE OF "SECURITIES ASSOCIATES INTERNATIONAL."

MR JIM CAROLLA STATED THAT THEIR ADDRESS IS "400 NORTH DURHAM STREET HOUSTON, TEXAS." THEIR PHONE NUMBER ACCORDING TO MR. CAROLLA IS NOT LISTED IN THE DIRECTORY.

AS STATED IN OUR PHONE CONVERSATION, THIS INVESTIGATION HAS PURPORTEDLY TURNED UP EVIDENCE THAT LEE OZYALO IS INNOCENT AND THAT GOVERNMENT AGENCIES WERE INVOLVED. A REPORT IS SUPPOSED TO BE RELEASED IN FOUR MONTHS.

MR. CAROLLA IS ATTEMPTING TO LOCATE HIS TAPE OF THE INTERVIEW, AND IF IT HASN'T BEEN ERASED HE WILL FURNISH ME A COPY SOME TIME NEXT WEEK

I WILL KEEP YOU POSTED ON ANY FURTHER DEVELOPMENTS.
