Man Seized In Probe of JFK Slaying

First Arrest Made In New Orleans Official's Inquiry

NEW ORLEANS, March 1 (UPI)—A New Orleans man was arrested today in connection with "a conspiracy to assassinate President John F. Kennedy." It was the first arrest in District Attorney Jim Garrison's investigation of the 1963 Kennedy assassination. No immediate charge was filed.

The man was identified in a statement signed by the district attorney as Clay Shaw, 54, a well-known resident of New Orleans and former managing director of the Interna-

tional Trade Mart here.
The announcement was made outside the locked doors of Garrison's office at 6:40 p.m. by a spokesman for the office. The spokesman said Shaw had been questioned since about 2 p.m.

Garrison promised "arrests ... and convictions obtained" on Feb. 18, when he first confirmed reports that he was making a new investigation of the assassination in Dallas Nov. 22, 1963.

Shaw Subpoenaed

Later, he claimed to have "solved" the assassination and promised he would arrest everyone involved in it. Garrison maintains that he has uncovered a conspiracy overlooked by the Warren commis-

Shaw went to Garrison's office by himself after being subpoeaned by Garrison.

He was the second person so far to be summoned in the case. The first was James R. Lewallen 38, a guality control inspector for the Boeing Co.

Lewallen's attorney said Lewallen once shared an apart-See ORLEANS, A12, Col. 6

ment with David Ferrie, a key figure in Garrison's probe.

Ferrie was found read of a brain hemorrhage a week ago. Garrison called him a major figure in his probe.

Lewallen left the District Attorney's office today after a lengthy session. Garrison was absent from the office most of the day, but returned about 4

Personnel in the office indicated the questioning of the two men was handled by assistants.

In Mexico City, the newspaper Novedades said police have the names of at least 14 persons, including some U.S. nationals, with whom Lee Harvey Oswald, the accused assassin, had "direct or indirect" contact.

Oswald went by bus to Mexico City from New Orleans, where he was ostensibly a member of the pro-Castro
"Fair Play for Cuba Committee."
