What I didnt tell you was that I was meeting a fellow who had an invitation to the dinner and intended to introduce me to the President in leiu of setting up a meeting with him about tide Harnessing relative to a I4 claim patent granted to me in 1960 and which I had greatly improved. Most of my inventive work has been in harnessing natural force and involves gravity, the atmoshpere and also vacuity. I have been most successful, that is, if I dont die before I can guide if its development into the right hands. I did a lot of investigatifatory(WOW:(I sure misspelled that one did nt I?) work on the case after being told by another painter that Hank Killum saw a shot fired from a fireescape window on the building where the museum of the case is now, or was the last time I went down there.
