Dear Harold,

I keep hoping to get back up to see you and continue going through your files. I've been so tied up with Cuba, however, that I simply haven't had the chance. Maybe in the summer.

I was indeed involved in the Nassau conference back in 1995. In fact, I organizeed it. It was not really by invitation. COPA members were informed that it was to take place and anyone who wanted to come -- and pay their own way -- could do so. I hadn't met you then so it didn't occur to me to invite you. I quess it didn't matter if you couldn't have come anyway. It was quite successful. Escalante and Carlos Lechuga were there and gave careful presentations that were helpful, but that didn't by any means point us in any new directions. We'd hoped to do a follow-up conference in Havana at which Escalante would open some files to us. Unfortunately, he got caught in the battle there between hardliners and softliners and was removed from command. He now runs a medical research center.

I don't know whether you've seen his book, The Secret War. I enclose a copy. It doesn't deal with the assassination, except for the last few words. Escalante believes Cuban-Americans may have been the actual hit men. He has some circumstantial evidence of that but doesn't pretend to have anything solid.

Furiati, of course, is something else again. She has taken some stuff from Escalante and turned it into a full-blown case. It was rather funny. She did a conference in Rio in mid-1995, invited me, Wecht, and a series of others from COPA, as well as Escalante. She billed the conference "Who Killed Kennedy Will be Revealed at Rio," and apparently was rather expecting
