My dear Sam:-

Many thanks for the copy of the Congressional Record, date September 19th 1940, in which you call me an "semi-ill columnist".

Now I dont mind what names you call me, but one thing I will not stand for is that you charge that I am a Nazi agent, that is a lie, I am not now, nor never was a Agent for Nazi Germany. while of course my sympathies (political and Economic) are with the Hitler Government in its fight for a new world order, I have never received one cent from them, either directly or indirectly.

As you know I was one of the most outstanding speakers for the German-American Bund over the years even before the Friends of the New Germany was formed, in all that time I never received one cent for speaking at these meetings. for how could these crooks pay me when they were all taking the money themselves, and they collected many thousands of dollars at meetings which I addressed under the disguise it was for my services.

The German-American Bund was always a menace to the welfare of the German-American element in this Country, and they did more harm between the New Germany and the American Government than all the Anti-Nazi organizations combined insofar as the good neighbor policy was concerned, it was a blessing to the both Governments when it was broken up.

Yes, I was the only one that organized the Klan meeting at the Bund camp in New Jersey, I had my own reasons for doing this, but you can rest assured that they were purely American. For I hate the guts of those phonies that have taken control of the Bund, but it is as dead as a red herring and smells worse. The present leaders of the Bund hate me because I was wise to their "racket" for a long time, and I was not afraid to tell them too, and back it up with my fists if, and when necessary.
