At 5:30 p.m., 3/5/64, Supervisor [redacted] Dallas Office, advised that he had contacted the Bureau and the Bureau had determined that subject had entered the United States at New York on 11/19/63, and had departed the United States for Mexico, at Laredo, Texas, 12/6/63. There was no information concerning any expulsion. ALDERSON had been interviewed by the Houston Office and he had had a slight acquaintanceship with subject in France but had not seen him since.

The Bureau instructed Dallas to tell San Antonio Office to close its file with a memorandum to the file. Dallas is doing the same thing.

Re memo of SA [REDACTED] at Dallas dated 3/5/64
which is serial 1 of the file.

On 3/5/64 [REDACTED], CMA Airlines, International
Airport, advised that there are three airlines with flights
in and out of Mexico, namely, CMA, American, and Braniff.
[REDACTED] stated that the passenger manifests for CMA Airlines
could be located for November 20, 1963, through November 25,
1963, at the CMA office at International Airport.

On 3/5/64 [REDACTED], American Airlines, International
Airport, advised that the manifests for incoming and outgoing
flights to Mexico for American Airlines for November 20, 1963,
through November 25, 1963, would have been sent at this late
date to the American Airlines, New York, New York. [REDACTED]
stated that he also believed that American Airlines manifests
in Mexico would also have been sent to the American Airlines in
New York.

On March 5, 1964, [REDACTED] Braniff Airways,
International Airport, advised that their flight manifests are
only kept for three months, at which time they are destroyed.
She stated, however, that a copy of Form I-94 is sent to
Immigration, and she stated that perhaps Immigration might have
a copy of this form which lists the passengers on the various
Braniff flights going in and out of Mexico.

[REDACTED] stated that they would have no record at
Braniff Airways in San Antonio, Texas, of passengers leaving or
arriving at International Airport on Braniff Airways from
November 20, 1963, to November 25, 1963.
