THERE HEVER HAS BEEN THIS KIND OF PROPER INQUIRY INTO THIS HOMICIDE.  
EVIDENCE WAS SUPPRESSED, OVERTLY, BY NOT USING IT AND COVERTLY BY  
NOT OBTAINING IT.

MUCH OTHER EVIDENCE ALSO WAS SUPPRESSED AND IGNORED, OTHER AND  
IMPORTANT WITNESSES NOT CALLED. WITH OSWALD THE ONLY CANDIDATE  
FOR ASSASSIN, IT BECAME NECESSARY TO PLACE HIM AT THE SCENE,  
AS WITH DALLAS POLICEMAN J.D. TIPPIT. THIS EVIDENCE WAS

IN HIS OPENING REMARKS ON SEPTEMBER 25, 1978, CHAIRMAN STOKES SAID:
