Thank you very much for taking the time to write me. There are many places from which shots could have come, and of these, the grassy knoll and the other building are two of the most probable.

What a private citizen can do is indeed a question when one considers what is mobilised against any proper consideration of the subject. The most obvious, I suppose, is writing legislators. This may at least draw their attention to the existence of a story other than the official one and letwing them know that the best that can be said for the official account is that it is dubious and perhaps dictated by expediency.

I do agree that there is much involved her, obviously, then a simple murder case. The entire national integrity is involved.

Probably by new copies of the book are available in many of the NY bookstores. The appearance on the Long John Nebel show seems to have attracted some attention.
