I have an interest in only what I think you do not have, a transcript of what the JAMA editor whose name at the moment escapes me said and his responses to questions. I have the text of his prepared remarks. I've written all I will about him but I'm curious about how he responded to some of the questions I'm sure he was asked. I expect that delayed book to be out about this coming September.


Dear Harold,

I visited you September 11th, 1993 and did an interview with you. When I sent you a copy of the interview and some other programs you wrote me a letter and thanked me for sending the tapes and wished me luck with my project. I really appreciate that you took the time and effort to do that. Many of the persons I have sent tapes to don't bother to respond. I again want to express my appreciation for doing the interview despite your health at the time. I hope you are doing well.

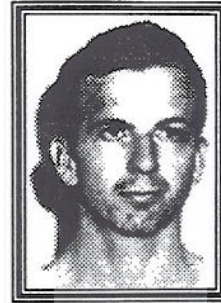
I am sending an advance copy of my just-completed documentary project entitled **JFK: The Investigations**. I took a look at the investigative work done in the last 30 years on the JFK assassination case. I am also enclosing some promotional literature. I was completely self-funded so I was able to remain totally independent and maintain editorial control. I suppose it's roughly the video equivalent of a self-published book. It may not look as slick and flashy as a network production but it certainly is a lot closer to reality than the recent barrage of pro-Posner lone-assassin propaganda that typified the mainstream media coverage of the 30th anniversary. There are several clips from our interview in the program. It was very difficult to keep the program to a length that would fit on one cassette. There were many other topics I wanted to cover but ran short of time. I had 50 people on tape, about 150 hours of symposium/lecture footage and 20 original interviews. This case is so complex with so many stories within stories that I could do a two hour program on any of dozens of subjects relating to the assassination.

I tried to take a somewhat conservative approach to the conspiracy angle on the case. There has been so much bad work done over the years that I tried not to be reckless and accuse any one faction of carrying out the assassination. I don't think its possible to responsibly point the finger at any one person or group that may have carried out the plot. I do briefly describe some of the theories and stated an opinion as to which may be the most plausible of the possibilities. I hope you don't judge me too harshly for that. I know there will be persons shown in the program that you may not approve of but I tried to avoid some of the nuttier ones that are out there. I think that illustrates one of the real tragedies of this case that, because of these terrible government investigations that no one believes, we are left with a legion of rank amateurs, (excepting yourself and a handfull of others), to continue to look for the answer to the crime of the century. It's sad that at this late date there may be no answer left to find.
