etc. The rest was washed
away, picked up (shortly
afterward) by the city sweeper.
To me, I find parallels to
the Nazi crews of WWII!!
Whoever was responsibly
was careless, or sure of
their not being held guilty
as yet, if an inspector were
sincere, I believe.

I know you can read me,
because you are a writer
and publisher yourself.

I won't list what I
consider to be evidence items,
but for example in the ashes,
dust, etc. was the metal which
was had melted, silver-colored.

Or could they have used wire
to open door? I don't know. (2)

Part of it to me, seemed to
be from the wire that, loosely
tied to the door on the driver's
side had probably been ~~for~~
binding a person to hold
him seated erect. Had burnt
and then possibly, the horn
commenced. After a few
moments of that, when I
looked out, shocked to see
the flames inside the closed up
vehicle, the scene was horrible.

Whether the person and I

I could see that though the flames were shooting out, they outlined what appeared to be a human form. My imagination could only take over, but I knew that it could be like the other cases. Once I had seen one of the cars afterward when the fire dept. was through, and I said ~~something~~ someone may have been in the car. The fire dept. men merely said "this may be a job for the police".

He had been in OKla. City. and
his ~~VA~~ money was accumulating
