STATEMENT BY J.C. IAMURRI TO THE LOS ANGELES POLICE COMMISSION ON BEHALF OF LOS ANGELES COUNTY SUPERVISOR MICHAEL D. ANTONOVICH February 12, 1986

Last August 13th, after the Police Commission announced intentions to release part of the record of the investigation of the assassination of Senator Kennedy, the County Board of Supervisors took exception to the limited scope of the decision.

Supervisor Antonovich introduced a motion that respectfully requested the Police Commission to authorize full release of the Kennedy assassination files. The motion was seconded by Supervisor Edmund D. Edelman and was adopted unanimously.

Supervisor Antonovich and his colleagues expressed the belief that under a democratic government, there is a presumption in favor of the public's right to know. This is a non-partisan issue. All Americans have the right to know the facts.

This presumption does not, of course, negate the common sense assumption that in some cases this right to know can be overridden by considerations of public safety.

But nearly 18 years have passed since the death of Senator Kennedy. Confidentiality, by itself, is a weak excuse for withholding this information from the public. All members of the Los Angeles County Board of Supervisors agree that neither public safety nor national security could be endangered by release of the report.

Mr. Antonovich urges the Board to listen to these pleas fairly and objectively, and to respect that precious "right to know."

Police accused of stalling release of RFK death files

A former political campaign adviser to Robert F. Kennedy accused the Los Angeles Police Commission Wednesday of stalling the release of investigative files into the 1968 assassination of the senator.

"You have been using every legal means to obstruct us in getting them," said Paul Schrade. "I have grave concerns about the intent of the commission."

Schrade and several other people who have requested some 50,000 pages of documents involving the June 5, 1968, killing of Kennedy appeared before the commission to protest delays in releasing the files.

"This is on its way to becoming a national disgrace in terms of public disclosure," said Philip Melanson, a director of the Robert Kennedy Assassination Archive at Southeastern Massachusetts University.

The commission agreed last year to release an edited version of the 1,500-page investigative summary and to study the disclosure of the remaining files in the case.

However, no information has been released since then.

The possibility that more than 1 assassin shot RFK is raised

Commission president Robert M. Talcott said he hopes that "a certain portion of the materials" will be released on March 4 along with a plan for the phased disclosure of the massive investigation.

Commission vice president Barbara L. Schlei apologized for the delay in releasing the 10-volume summary.

"We have been too slow but I would like to assure you that to the best of my knowledge there has been no coverup; there has been no coverup," she said.

Schrade, Melanson and Gregory Stone, a former aide to Congressman Allard K. Lowenstein, submitted a proposal for the phased release of the Kennedy files that would be implemented by the commission with the participation of a panel of experts.

Most of the files could be re-

viewed and released within two years, according to the proposal.

Schrade was wounded in the head when convicted assassin Sirhan B. Sirhan opened fire on Kennedy after the presidential candidate gave his victory speech at the Ambassador Hotel in Los Angeles the night of the Democratic primary.

"I was a victim of that shooting," Schrade said. "I want (the documents) and other people want them because there are unanswered questions about the case."

Among those questions, he said, is the possibility that more than one assassin shot Kennedy as he walked through the kitchen area of the hotel.

Schrade told commissioners that the police version of his shooting doesn't match ballistics simulation of the event.

"The simulation shows that bullet could not have ended up in my head if it passed through Robert Kennedy's coat as stated," he said.

Outside the commission meeting, Schrade termed the police summary "practically meaningless" but he said release of those documents would be the beginning of the process of disclosing the raw investigative files.
