If bu want to ask that the single request include all field offices, which your test indicates, you are asking for trouble and assuring, I think, that the FHI will isome the until it is litigated.

Last sentence, page 1: Else indices, plural, because they also index heards and mentioned, otherwise they'll semb, if at all, by subject of surveillance only.

Perhaps it is a good idea (pa, 2, graf 1) to ask in advance for all FBI names, perhaps it isn't in advance of protecting because of their position, which you do not mention, that privacy requires a thindding. If you go this way I think you should include evidence of prior disclosure course the privacy claim can be invoked only when there is privacy to protect. I'm wretty sure that with your formulation alone they'll invoke, among other things, the recent intenalli appeals court decision.

Graf 2, reference to "your office" confusing because you address FMHQ and not any field office. Substitute "recodes of the field offices."

You also argue at the end, so I suggest substituting "matter of continued intense public interest and controversy, with central issues and basic facts remaining questioned."

Page 3, pentit graft why do you ask than to phone? I think you are netter off having everything in writing because they'lly lie anyway. But if it is in writing you can produce that and this can have an advantage.

Last gref is unnecessary and impossible and will be taken as arrogent and perhaps self-important. They know the requirements of the Act and it just is not possible for them to respond in 10 days, as they and every court knows.

We request a complete and thorough search of all filing systems and locations for all field office records maintained by the FBI pertaining to the assassination of Senator Robert F. Kennedy and investigative a tivities related thereto, including but not limited to files and documen s captioned in, or whose captions include the names of Sirhan Sirhan or Robert F. Kennedy, or logical variants thereof, in the title. This request specifically includes "main" files and "see references," including bu not limited to numbered and lettered subfiles, lA envelopes, enclosures behind files (EBFs), Bulky Exhibits, control files, ticklers, agent intervie notes, abstracts, index cards and "JUNE" files. We want all records to be produced with the administrative markings and all reports to include | the administrative pages. This request specifically includes the 10-voluhe report of the police investigative unit known as "Special Unit-Senato :" and all records in any way pertaining thereto. We want all records of the Los Angeles field office regardless of whether they have been previously processed for us or any other requester.

We wish to be sent copies of "see reference" cards, abstracts, search slips including search slips used to process this request, file covers, multiple copies of the same document if they contain notations distinguishing them from other copies, and tapes of any electronic surveillances. Please search "DO NOT FILE" files, SAC safes, special file rooms, and offices of FBI officials. I want all pages released regardless of the extent of excising, even if all that remains are the stationery headings

In addition to a search of the General Index, please search the ELSUR Index and any special case index.

We request, as well, that the names of the FBI Special Agents (and other personnel) involved in the investigation not be routinely deleted in the documents provided, absent specific facts showing that there is serious threat of danger or personal jeopardy which would result from such disclosure. This matter is particularly significant as the reports of some law enforcement personnel in this case, as well as Felevant FEI documents hithertoo released are at odds with the standard official interpretation of central issues of the case. It should be noted in this connection that the Warren Commission released thousands of documents concerning the assassination of Fresident Kennedy, a comparable situation, without ever deleting the names of the investigating agents involved.

We would like to make it clear that we want all records in your office "identifiable with our request" even though reports based on those records have been sent to FBI Headquarters and even though there may be duplication between the two sets of files. Please do not refer to Headquarters.

Please search for records under the following names: Robert Francis Kennedy, Sirhan Bishara Sirhan, Adel Sirhan, Bishara Sirhan, Mary Sirhan, Munir ("Joe") Sirhan, Saidallah Sirhan, Sharif Sirhan, William Joseph Bryan, Jr., Thane Eugene Cesar, John Fahey, Robert Gindroz, Oliver B. ("Jerry" or "Curley") Owen, Henry Donald Ramistella (aka Frank Donnara uma), Thomas Rathke, Donald Schulman, Paul Sharaga, Edward van Antwerp, Rosi (Ancient Mystical Order of Rosae Crucis), Ace Guard (or Ace-Guard) Service (Los Angeles area), or logical variants thereof.

Please place any "missing" files pertaining to this request on "special locate" and advise me that you have done this.

We believe that this request qualifies for a waiver of fees since release of the requested information would primarily benefit the general public and be "in the public interest." The Robert Kennedy assassination was clearly a major public tragedy, but in comparison with comparable even less important) cases, relatively little official information continuous it has ever come to light. In consequence of this fact, and of basic lems and unanswered questions in the present evidence, the case has been a matter of repeated public controversy, with central issues still in findamental doubt.

One of the requesters, Gregory Stone, has been active in work on of this case since 1974. During much of that time, he worked closely on these questions with the late Congressman and Ambassador Allard K. Lowenste n, worked on relevant articles and presentations, and drafted with him a manuscript of over 250 pages detailing central issues of this case. He is interested in the possibility of publication of a revised version of this manuscript, as of other possible publications. He has recently been active in pursuing

additional official and non-official sources of information in the case has been in touch with others of similar interests. His interest in the case relates both to public interest and scholarly concerns; he sponsored in academic project in that connection last January and has assisted other related academic efforts. He has a master's degree in political science at the University of Wisconsin at Madison, and was co-editor, in 1973, of a published book touched in part on these issues.

Dear Mr. Stone:

I am writing to you in answer to your letter of March 13 addressed to Mr. William Moss. Mr. Moss left the Kennedy Library in December to become Archivist of the Smithsonian Institution.

The Kennedy Library has never actively pursued either John or Robert Kennedy assassination related materials other than published works. To do so would tie up too large a proportion of staff, time and resources on items which would not greatly contribute to the study of the contributions which both of these men made to American history. Depending on their extent, if the collections were donated here they would not be given high priority for indexing and processing, as very little in the way of processing is currently underway primarily due to losses in staff. There are also richer collections in terms of historical study which must be processed first. Thus the prospect of the immediate usefulness of the materials which you mention is indeed slim, it would be many years in the future.

Thank you for the two articles which you sent with your letter, and for your interest in the John Fitzgerald Kennedy Library.
