Enclosed is the reply I have sent to Mr. Cobb of the Robbery-Hom cide Division in response to his remarkable letter.

As I mentioned on the telephone on Monday, I would appreciate a : esponse to my letter of a month ago (copy attached) concerning the answers given to earlier inquiries on the Robert Kennedy case-pursuant to the Polic. Commission procedure established in 1975. You mentioned hypothetically in that conversation that Police Commission policies may be changed, although stated that you had no knowledge to that effect in this matter, nor, of the formal Police Commission procedure which is the basis of this process. Absent contrary information, I will make the routine assumption that the 1975 commitments were entered into seriously, and not as a matter of deceptiveness or whimsy. As you know, this assassination is not a plous matter.

Although my requests have been at all times directed to the Police Commission, you stated that you had no knowledge of Mr. Cobb's letter, and there is no inkling in it of any consulation by him with anyone connected with the Police Commission in connection with his response. Leaving aside the disregard for your agency which this posture displays, it suggests that future communications on this matter will best be channelled through the Police Commission, to avoid further waste of time. My request was ard is to the commission, not to the Police Department.

My assumption over the past several months that this matter was processed in good faith has apparently been misplaced. As you were not directly involved during much of this period, I assume that you will be concerned about this sequence of evasion and inaction. The initial were deliberately framed to be elementary and easily responded to, g minimal grasp by the agencies involved of the material in this case. by no means exhaust the basic unresolved issues about the assassinat they do pose some matters which are usefully clarified at this point Few of those familiar with the number and gravity of the fundamental questions existing about the Robert Kennedy assassination believed that the Police Commission policy established in 1975 was adequate or substantially responsive to the public's right to know in this matter. It was specifically designed and adopted by the Police Commission itself, in preference to other proposals which were both more forthcoming and effective and more easily administered, for addressing the informational issues of this case. Leaving the broader questions aside, however, I have confined my initial inquiry thus far to the terms of the established policy, which is explicitly cited in the first sentence of my October letter.

I would appreciate receiving now either answers to the questions submitted to date or an indication as to when they will begin to become available.

Your letter of June 26 concerning information regarding the Robert F. Kennedy assassination is incomprehensible to me.

by initial request for information, now nearly nine months old, was addressed not to the Police Department but the the Board of Police & mmissioners. As that board has made explicit and public commitments (concurred in by the police), your reference to standard procedures in criminal investigations is inapposite. The October, 1983 letter to which you make reference was clearly premised on these commitments, which your response entirely ignores. Although you reply in the name of Mr. Gates, your letter flatly contradicts his specific assurances of the exact points at issues.

As my request was directed to the Police Commission, I wish to know who, if anyone, in that body you contacted before arriving at the views expressed in your letter. If no one, on what basis did you reply on that agency's behalf? •

Your claim that "the Superior Court has ordered that the Departm mt's files on the (assassination) investigation remain confidential" is ab plutely unsupported by any information of which I am aware. Please provide documentation and/or citation to indicate the basis of this claim. and a star of the star of the star of the

. I am also perturbed by what has become a series of either uninformed or purposely deceptive responses from the Los Angeles officials to whom I have been referred on this matter. For example, your remarks contradict the assurance (three weeks previous) by Mr. Bonino of the Records and Identification Division that "the depth and complexity of the investigation has . required special handling" and that two officers had been assigned to that task. In addition, I am surprised at the assertion that the City Attorney's office (which also concurred in the policy cited above) rendered the alvice which you describe, particularly at any time preceding the assurances [have received that this matter was being actively pursued. Who in that office furnished this advice and when?
