

## MAJOR ANNOUNCEMENT

### \*\*\* EDITOR OF JAMA TO PARTICIPATE IN 1993 CHICAGO CONFERENCE \*\*\*

- A team of physicians, headed by Dr. George D. Lundberg, the Editor of the Journal of the American Medical Association (JAMA), have agreed (in writing) to participate in our 1993 conference to discuss the medical evidence in the JFK case. Dr. Lundberg will be joined by Dr. John Lattimer M.D. Sc.D., Dr. Michael West D.D.S., and Dr. Marc Micozzi M.D. Ph.D.
- They will present their opinions of JFK's autopsy as reported in the 1964 Warren Commission Report and JAMA in 1992. We expect their observations to be largely supportive of the findings and conclusions of JFK autopsy physicians Humes, Finck, and Boswell.
- After their presentation, a team of Warren Commission critics will present an opposing viewpoint on the medical evidence. This team will be comprised of David Lifton, the author of *"Best Evidence"*, Wallace Milam, Roger Feinman, and Dr. Cyril Wecht.
- Afterward, Q&A and rebuttal between both teams will be allowed under the control of an independent moderator. Both teams will also be allowed to use photos, illustrations, and videotape to dramatize their observations and conclusions. The session will be 3-4 hours in length and will be held on Saturday morning, at 9 AM, April 3rd.

### Other Announcements

- We've finalized our reception and dinner for Saturday evening, April 3rd. The Saturday evening activities will begin at 6 PM with a 90-minute social hour. This will be the best time during the symposium to "talk shop" with other attendees and to meet our guest speakers. Dinner will be served at 7:30, and will be followed by speeches by former HSCA Deputy Counsel Robert Tanenbaum and Rev. James Bevel, a former strategist and aid to Martin Luther King who was with him when he was shot in Memphis. We are holding open a third speaking slot for a yet to be identified person, hopefully a prominent figure. The admission fee to the reception and dinner will be \$35.
- As of January 15, 1993, none of our guest speakers have cancelled. To minimize the possibility of cancellations, all guest speakers are being provided with advance roundtrip air fare and lodging expenses for two days during their stay in Chicago.
