Dear Jim,

I had to stop reading Posner for two reasons. One is that I was getting too excited over the real possibilities I see in it and the other is the reason that I have been avidly ^{back} harback books of any size for several years. If they slip and an edge hits my skin, the upper layer just peels back. I stopped for that ~~repair~~ repair... And I do not remember what I wrote you yesterday. I am up only to p. 150 in the trash, which it is.

The more I get into it the more I believe that Posner got the idea of the book as he presented it to me as what would be welcomed as a response to Stone and his movie. Either he deceived me or the concept was broadened, and while there is no proof I have a pretty solid case that like Epstein he accepted official help and thus broadened his book. There are substantial indications this included the CIA. Only a third of the way through the book I believe he could not have located and interviewed all those he refers to without some help. There are more substantial indications for which I do not take time. What I want to add to what I told you is that it gets into and I think will get more into what can clobber the Commission's counsel and its Report. I am at a point where I have and have FBI reports on pictures that destroy Posner's version of that fracas with Bringuier Oswald had and have a receipt in Bringuier's own handwriting that proves he lied to the Commission, along with a change in the stenographic transcript before printing, by Lieveler, to eliminate a witness's effort to tell him Bringuier lied.

I'm not going to try to give you more details, I'm a bit too excited about the real possibilities if Stone were to get interested and do a documentary with me. Yes, I know how he can feel but I think if he speaks to his PR people they will tell him that can add materially to the impact and significance. Whatever he does, I am going to do what I laid other work important to me aside to do, a definitive job on Posner and his whoring. (I wonder if the title, Literary Whoring with the JFK Assassination would appeal to Stone?)

My procedure will continue to be to annotate the book for the historical record. I've been doing this for Dave and with him from time to time. This time I'm going farther. I'll will xerox the pages I've annotated, I'll use them for writing and then I'll give them to Dave. (I've begun to skip in the book because there is already too much to use, even in a book were I to do one, because I have only so much time and want to complete a book I've started and want to finish (in which I can use this) and because, on the remote chance his ego does not dominate Stone, I want to get as much done as I can as fast as I can... You may recall having heard me refer to using using intellectual judo. This is a fantastic opportunity for that... Dave and I have been talking about the things that can be done, he made some copies here and I presume he gave you them. They are but a drop in an ocean, I'll have that much more. But I doubt Stone will be able to detach himself from the past and be able to see what this can do for him and for what he said he did JFK for. If you hear anything about the book, please let me know, with a copy, that is.
