Dear Richard Sullins,

I do not have all the New Orleans testimony, as you say Bud Fensterwald told you. However, I do have Finck's. It is a rather poor Thermofax, one that would not reproduce well and one I would hesitate to risk in the mails because of what has happened to some of my mail.

You ask for a vast amount in "Information, especially pictures, of David Ferrie;" "Pictures made at the scene of the assassination" (I presume Bud has about what I do on this); and "Information on the disappearance of the Stemmons Freeway sign."

I think you should understand that those of us who write books have as a purpose informing people. Your letter indicates an unfamiliarity with some of what I have published. Obviously, I can't take the time to write that all for anyone thereafter.

Your purposes are your own affair. However, your letter does indicate a lack of familiarity with the basic published information. Therefore, I wonder if you are going into what you may not be properly prepared for.

There is a school of thought that holds fact and knowledge are irrelevant, but I do not belong to that school.

I am not avoiding answer. You ask the impossible of me. I can't begin to send you those of the requests in my files. I have an enormous amount on Ferrie. However, I also plan to write about it hence can't give it away. Moreover, I do not put others in a position to engage in uses prior to publication that I may believe not proper.


You indicate a wide interest yet display no familiarity with the basic literature. Were I to give you this material, are you really in a position to digest it?

Perhaps if I knew your purposes I might be able to be more helpful. But you ask for materials that could fill several books. That is quite beyond easy response.

In any event, I do believe that prior to going off on your own you should be familiar with what has been published, not all of which is dependable. Without a solid grasp of the fundamental and available information you may err seriously and waste much time.

My Oswald in New Orleans is out of print. I have only a couple of copies and do not let any go without good reason and then for the replacement cost of \$21, which is for most people prohibitive. In it I have what was generally known about Ferrie as of early 1967 plus what I'd by then found in the Archives, FBI and Secret Service reports. I brought him to light in my second book. Neither book includes the picture of him which are readily available from news agencies and were published in early 1967.
