Dear Mr. Rankin:

There are forwarded herewith copies of reports from the Secret Service files relative to the assassination of President Kennedy.

A list identifying the reports by SS control numbers is attached.

Our files contain a number of documents classified as SECRET and identified by Secret Service control numbers 157, 161, 162, 163, 164, 165, 166, 171, 172, 174, and 409. Since these were received from other agencies, they cannot be released by us. I suggest that a member of the Commission's staff, holding the proper security clearance, review these documents in our files and determine which ones the Commission considers pertinent. Requests can then be made of the submitting agency for copies.

As indicated in my letter of January 6, 1964, the remaining files of the Secret Service are available for review by your staff for the purpose of extracting any additional reports or information contained therein. The attached reports were selected as being, in our judgment, information of paramount interest to the Commission at this time.

The enclosures also include a group of still photographs reconstructing the assassination scene, including photographs taken through a telescopic lens.

Reports submitted subsequent to our review of the files on January 6, 1964, will be forwarded to you periodically.

This file consists of five large bound volumes. When I examined it last week this letter and the attachment were loose in the front. I ordered them on the chance they might implicate what Paul had been collecting on this subject.

Of those listed as classified in the letter, not one is in GD 87, nor is there a green sheet covering any.

I assure from this that of the listed reports, only those mentioned by Rowley in the letter are properly classified.

Inherent in all of this is the suggestion Rowley has sent only what he considers of "Laramont interest" to the Commission only. Others might have different judgement.

In short, this strongly suggests he didn't send everything to the Commission, hence the Commission's files cannot contain all.
