
Dear Sir:

Although you stated in your letter of 12 January, that you could be of no assistance in obtaining records from Parkland Memorial Hospital, I think that in this instance, that you may be able to render such assistance.

In the Exhibits mentioned above, there are several instances where suspicious persons were observed and the license numbers of their cars reported. However, there is no mention in any of the available documents in the National Archives which identifies these persons.

1. A white 1961-62 Pontiac stationwagon with two white male occupants observed at 4340 West Davis with a shotgun or rifle in back seat
2. A suspects car at Cobb Stadium, license number 3E9087
3. Suspects observed at 5818 Belmont. A Falcon with plates NX 3171 and another car with plates RB 8950
4. 2957 Chevy sedan with plates NA 4445, carrying consealed weapons in the area where Tippit was shot.

I'm sure that local law enforcement agencies must have checked out these cars and identified their ownership. This information is not available through the Archives and I wonder if you would assist in supplying it to me?
