If your papers are giving the O.J. Simpson case anything like the attention to it here I'm sure you will have noticed that the defense counsel's complaints about that investigation will sound familiar.

Those same things happened in the JFK case extensively, less extensively but no less importantly in the King case and even in the Robert Kennedy case, with the same Los Angeles police

The difference, of course, begins with a prominent defendant and his expert counsel, the fact that trials are public and that the Commission did all its work in secret.
