Dear Mr. Weisberg,

I WILL BE GLAD TO FURNISH YOU WITH COMPLETE DOCUMENTS AND REFERENCE NUMBERS IF YOU WISH. I MERELY SENT THE MATERIAL ALONG WHICH WAS OUTSTANDING.

IF YOU CHECK MY LETTER I DID NOT THEORIZE ABOUT THE MATERIAL I SENT. ALTHOUGH THE CIA IS CITED QUITE A BIT, I DREW NO CONCLUSIONS. I AM AWARE THAT THE CIA, ALTHOUGH CAPABLE OF KILLING JFK (OR ANYONE) COULD NEVER, ALONE, SUCCESSFULLY COVER IT UP FOR 15 YEARS. I CAN UNDERSTAND WHY YOU WOULD ASSUME I WAS TAKING A POSITION AGAINST THE CIA AS THE CULPRITS, BUT THE FACT THAT THE DOCUMENTS WERE MOSTLY CIA-ORIENTED WAS COINCIDENTAL.

AS FAR AS THE 201 FILE IS CONCERNED, I WAS JUST TRYING TO ASCERTAIN WHO'S TELLING THE TRUTH - THE CIA OR THE EX-AGENTS.

JOHN NICHOLS. I'LL BE GLAD TO INFORM YOU OF ANY
NEW DEVELOPMENTS I.E. NICHOLS' NAA STUDY OF THE FBI'S
LAB NOTES SOON BE FINISHED).
