Thornley & Dolan

D. "He never learned to drive a car did he?"

T. "That's - uh - that's what I'm told."

T. "Strangely enough his favorite book was 1984. --- In my own mind, I had labelled him as a paria communist."

On Oswald's rifleman capacity:

T. "He had a marksmans medal, I am told --- it means that he was a better shot than the average man. However, I later had a chance to visit Dallas after assassination --- I think it would have been an easy shot."

Dolan = "Of course you didn't ^{know} Marina"

Thornley = "No, I didn't."

Dolan = on how Oswald could escape detection as a Communist
Thornley = "This is one point where I have to disagree ^{with} ^{Marine Corps} with the critics --- pink in our sympathies. I summed it up in my book you don't train and go over and be an ambassador ---"

Thornley = "MACS-1 - discipline was very lax in this outfit."

Dolan = "Would you think of O committing such a crime?"

Thornley = "I have no reason to think of the guy on it" --- This is a hard thing to judge about a man.

Dolan = Have you had any contact with ^{Marquise Oswald, Marina Oswald}

Thornley = ~~no~~ ^{My wife} My wife ^{Oswald} Oswald sent me a letter

after reading about me.
she read about the "Idle Warriors".
I turned it over to a gentleman who was acting
as my agent (request by Marguerite Oswald)

Dolan = What do you think of the conjectures on Warren Report?

Thornley = "when WR came out
--- when 26 volumes came out & I scanned
those --- now I'm very skeptical --- right now
I'm thinking he was probably framed. ---

--- I haven't read any of the books of the
critics, any knowledge of them comes second-hand
.....

testimony of
R. Craig -- (p. 157 of Bantam issue) -- this
created doubts -- (on ~~his~~ identification of Oswald.)
Dolan = do you think ~~we~~ ^{one} should have been appointed to defend Oswald.
Thornley = No I don't. I don't think the WC should
have been convened.... I think the gov't should have
staged out of it completely."

Dolan = on Oswald as a party
Thornley = (said it was on television) --- "it was
cut off on a number of stations

Dolan (on Ruby) =

Thornley = "he said high govt officials were involved."

Dolan = (on Marina's testimony)

Thornley = "from what I gather of Marina
and this is all second-hand --- she wasn't
the poor innocent girl we all thought of"
