Jean Daniel: To Paul is attached a copy of CDI482, which may be only the first page of that GD, from the GAL-State files. I got it yesterday, together with a few on Alba, because they will make a few while you wait. If Gary should want a copy, please make it for him. This should be followed further for narrow reasons of my own, but in order not to attract interest in my interest and because it takes an interminably long for my orders to get filled, I will not attempt it by mail. I will examine this file when next I am at the Archives. And I note Paul has 3 pages from it. If they are relevant to what follows, I'd like a copy. Sorry, what Paul has is 1572. Nothing listed for 1482. Anyway, I want to ask this note for the future, as I send you both a copy and if I want Paul to carry it further I will ask him.

You both know that before I printed the general distribution edition of *WE* I had researched and was read to write what I'd planned as my second work, *TEGER TO NINE*. I laid it aside and did *WHI* and what follows because I believed the doctrine of the work following it were not conducive to establishment of the truth and because I decided that more part of the assassination itself was of higher priority. Ted. Tufersan told me years ago that if available then *TEGER* could sell in the hundreds of thousands. I am still hopeful it can be a successful commercial book. So, I have a separate file on *TEGER*. It takes up an entire file drawer, and this is exclusive of a stack of unclassified notes perhaps a foot high, stored elsewhere, and a number of books from which I'll quote at length. I have in it a Jean Daniel file, for which, after he copies, if he desires, I'd appreciate it if Paul could return this copy.

In any genuine GAL-State file, all material attached to this letter from Frank to Slavson should have been included. One of it is. Without knowledge of Daniel's writing, there seems to be no significance in its omission. I had loaned my copies of the article referred to and it had not been returned, so I tried to get a copy from Daniel, who undoubtedly had more, and got no response. He is the foreign editor of a French paper, or was then, and I had a correspondent mutual friend ask him. He is significant for a number of reasons:

He was with Castro when Castro learned of the assassination;

He was the last foreign correspondent, if not the last correspondent, to see JFK;

JFK did give him an unofficial mission, and asked him to return for another private meeting after he saw Castro.

Rather than being anti-JFK, before the assassination, Castro had told Daniel that, with the changes in his policies, JFK was becoming a great President and might go down in history as another Washington or Lincoln. This is hardly consistent with knocking him off.

Each of the four items sent the Commission by State is interesting. The first, the single Daniel New Republic article of 12/14/63, details the foregoing. However, it is but a single one of the four articles Daniel wrote for the New Republic at that time and dealing with this. I got these at the New Republic. I wonder why State sent only this one, when it is part of a series on the same subject. And, without doubt, his writing for his own paper was more extensive. No reference to fact. 2 is copies of Castro's speeches of "the relevant period". We know one reason these may not be in this file (O in NO). I have no recollection of what could be in 3, relevant speeches by US Govt officials. Nor do I recall Slavson's memo of 8/30/64, which I did not see in this file. The first paragraph says it asked "additional information" on the Daniel article (which is not the same as copies

of the article. If this letter is an accurate reflection of the response, then State was careful not to commit itself, not to express any opinion, make any interpretation, give any analysis. Instead it had limited raw material and not how late the date, September 3, and the lateness of the inquiry, 8/30, that the report had been written for some time.

Should you be interested in these articles, I will send them to you. If doubt if they can be replaced today, except by mailing.

This one thing has been a special interest with me for some time. I'd appreciate your not calling anyone's attention to it because I want to hold it and use it in the larger context of WICK. It is the kind of thing that can attract minor attention by itself while accomplishing nothing.

When I write to you for some things asked in last week's memo on the Hill-State file, I'll include the Slawson memo, and I'll keep you posted. Meanwhile, if either of you has anything relevant, I'd like to know about it. Because of this offhand handling, I am establishing a second Jean Dental file with my Commission work. In my separate WICK file I also have some papers, including the nature and content of which are not clear to me. I know they relate to his being an "official" member of the staff and a very important position. It was an era in which everyone was, especially, "official" and "unofficial" things will be a matter of fact and not of opinion.
