WThe court is further diredited to Aquire into the deatis and fnjuxies to naval personncl, and as appoysiate, to portonn the duthes of En inguesta After deliberathoni the couns shan! submit its firndings of fact, optaiens ! and recomendations. The courb will expees ita opinico as to the line of duty and miscondust status of any injured pensonel and will reaomend adoinistuative os disalplitany actlon as appromsiato.
