Dear Mr. Deutsch:

Having missed your December 22, 1967, column and just gotten it in the mail, I must acknowledge missing only a disappointment because its dishonesty is as apparent as its bias.

You know very well the purpose of my call was not to tell you I was the "victim of a conspiracy" but to charge you with your personal responsibility in the proliferation of nonbooks, a rather good and then current column.

Of course, your paper and you are not biased, not partisan, devoted only to legitimate news. Therefore, last year, when Carlos Bringuiet filed a suit against me that was patently frivolous, this was news. When it was unceremoniously tossed out of court, it was not news.

When Mr. Dymond charged me with being in a conspiracy to deny his client his rights, that quite obviously was news. When Mr. Dymond, knowing from the moment of its conception, that he was lying, filed to subpoena me as a witness, although he subpoenaed thirty, and thus made clear that he was hiding behind the robes of the court to libel me, that quite naturally was not news.

Now Carlos Bringuiet has, as he can by the simple paying of a deposit, filed precisely the same entirely invalid suit as part of an open blackmail designed to keep me out of New Orleans and thus terminate my investigations, that again becomes news. What is normal in papers of even moderate dishonesty is a telephone call to the accused. Your paper consistently is silent.

Now, it is not because you are unaware of the kind of cheap operation that is involved here because when Bringuiet hired a United States Marshal to serve Xerox copies of the suit already thrown out of court on me when I was in New Orleans, in March, he carefully sought out your court reporter who declined to print the story because it had no validity.

Now, the most casual reading of what WHITEWASH says about Bringuiet, to even an apprentice cub reporter, discloses that it is totally immune from any suit because it is a quotation of testimony. But it is sufficient for the people of New Orleans for their reporters, from cubs to seniors, to pontificate: Why concern ourselves with the nasty details? The President is safely dead, anyway, isn't he?

I recognize writing you lays me as open to your venom, blindness and prejudice as trying to talk to you already has done, but at least between you and me, sir, there will be a record.

ODDBALL EXPERIENCE NO. 835-C: Received a phone call the other day from some one who said he is Mister X— (I have no wish to expose the name he gave me). He went on to explain that he has read my column from time to time, has no criticism to make of it, in fact is impressed by its scope, etc., etc.

He just wanted to tell that he, X—, is the victim of a conspiracy to keep from the public all knowledge of his latest book, the one he has published himself in paperback, that being all he could afford, and which no newspaper or magazine of general circulation reviewed or otherwise saw fit to mention, although he called a press conference here to announce that this was a book about Oswald in New Orleans, before he went to Dallas; that the book was based on more than 400 hitherto secret and unrevealed documents to which he had been given access; and although he had given out some copies of his book to the media representatives at the press conference, not a line about the book or what he said about it had appeared in any New Orleans newspaper. During the dinner Eberhard suddenly burst out: "Do you know anybody by the name of X—?" I replied that I had never met him, but had spoken with him at incredible length only that afternoon. "Well," continued Eberhard, "he called me up this morning and said he had been reading my newspaper columns and was impressed by them . . . and I told him he was talking to the wrong one of the Deutsch brothers, that he was Eberhard and the columnist was Hermann. He came back with something to the effect that I did write newspaper columns, didn't I? And again I told him no, that you were the columnist and I was a lawyer, and again he said he knew I was a lawyer but didn't I write newspaper columns too?"

'Might Have to Prosecute Garrison,' Clark Quoted

U.S. Atty. Gen. Ramsey Clark was quoted as saying in Charlottesville, Va., he "might have to prosecute (New Orleans Dist. Atty.) Jim Garrison."

However, in Washington, a spokesman for the Justice Department said it has no plans to bring a case against Garrison at this time.

The spokesman also denied

that Clark had accused Garrison of ruining prominent New Orleans businessman Clay L. Shaw.

Last night, in an informal question and answer session after a speech to the University of Virginia's Student Legal Forum, Clark is quoted as saying Garrison "took a perfectly fine man, Clay Shaw, and ruined him just for personal aggrandizement."

Shaw has been charged by Garrison with conspiring to murder President John F. Kennedy.

A reporter for the Charlottesville Daily Progress further quoted Clark with saying, "Much as I may hate to do it, I just might have to prosecute Jim Garrison."

He is not reported as elaborating on his remark, and did not specify what federal charge he contemplated against the DA.
