RE: INTERNAL MOBILE SECURITY UNIT TRAINING CAMP -
LOCATION OF.

On May 1, 1967, in an attempt to locate the training camp of the Internal Mobile Security Unit referred to in the statement of JOHN IRION, taken January 30, 1967, I went to the Courthouse in Covington, Louisiana to determine whether or not any properties were listed under the last name of PAUPART. The name GEORGE PAUPART appears in IRION's statement as being the name of a C.A.P. Cadet whose family is supposed to have made their property available as a training site. According to IRION this property was supposed to be located in the area of Abita Springs, Louisiana.

After checking the offices of the Assessor, Tax Collector, Sheriff and the Conveyance Office, the only name I was able to find was that of ANDRE J. PAUPART. This appears in Conveyance Office Book 261, p. 316, wherein ANDRE J. PAUPART along with a number of other people granted the State Highway Department a right-of-way on April 17, 1958, involving property which fronted on Louisiana State Highway 434, beginning at the intersection of Louisiana 434 and U.S. 190, proceeding in a Southwest direction for 1.59 miles. I was unable to find the name of ANDRE J. PAUPART in any other records of the Conveyance Office concerning this or any other properties.

It should be noted that the aforementioned described property is not located near Abita Springs but is in Lacomb, Louisiana. The property is described as Township 8 South, Range 13 East, Section 43. I checked on the names mentioned in the right-of-way recordation and was unable to find any reference to the last name PAUPART in the various documents.

In the company of Clem Neidermeier, after concluding the check on the name PAUPART, we attempted to locate the property hereinabove described. The area referred to in the description contained in the right-of-way deed is located in Lacomb, Louisiana. However, now knowing the exact location of the PAUPART property I was unable to pinpoint the camp. I did travel Louisiana 434 from the intersection of U.S. 190 for 1.6 miles in a Southwesterly direction.

While in this area I had occasion to check the telephone book and the U. S. Post Office in an attempt to locate the property owned by a PAUPART, or the name of PAUPART, but was unsuccessful.

I am attaching a photostatic copy of a map showing the location of this property which is indicated in green ink.

Upon returning to New Orleans, I had an occasion to interview JOHN IRION in my office and he informed me of a possible way to locate the party, GEORGE PAUPART, referred to in his previous statement. IRION stated that GEORGE PAUPART is a white male, 25 to 26 years, that he was a student at Delgado Trade School and that he lived with his parents somewhere in the Little Woods area. GEORGE PAUPART might be located through one ANDY DEVINE who either is or was an instructor at the Delgado Trade School and a close friend of GEORGE PAUPART.
