I have forgotten to take the roll of color film to be developed. I'd been waiting for the camera shop to phone with word my projector is repaired. They haven't. I'll remember in the next few days. There are a few pictures of you two on it.

<sup>Y</sup>ou are right about using the ground-glass view finder. I do it when I'm not in a hurry or when there is no glare from it.

I don't really know what it bothering me, but I do not believe it is cause for great concern (I appreciate yours). I had another and more severe speal of it, got a different doctor at the hospital and a different diagnosis. Unpleasant as it was, it was a considerable relief because the nurse in the emergency room was trating me for a stroke or a heart attack. He thinks it is anxiety with hyper-ventillation and the symptoms so frightening he says are typical of it. Previously, dissatisfied with the first diagnosis,  $\overline{1}$  had written our medical coop and asked that it be checked thoroughly and they det an appointment for today with a doctor who will decide. I'll be leaving after breakfast.

All the time I thought my nerves were of iron, except when I lost my cool (sometimes too easity). I rerely lose my temper (and I have one), never have trouble felling easleep and while I have worries, I didn't think they had such subconscious influence on me.

However, if this is the case, it does not trouble me. <sup>1</sup> have found I can take care of snything I understand. I've had a bad back for 30 years. I've been supposed to wear a brace, etc., and during my military service I even slept with it on. I don't know where it is now and once I deeply understood that either the back or I would be master it never kept me from doing a single thing - even on crutches. So, if this is a nervous disorder, and I am willing to believe it can be, I'll handle it.

I've had experience with a few agents, so when you have the name of the one of whom you write, tell me and I'll tell you if I know anything. I went through quite a few, but this subject is unique.

Keep us posted on your draft situation.

Your analysis of the NY left makes sense.

It's one of those periods of time when everything is about to break through, might at any minute, but on the other hand might just fizzle out. I guess we'll know in about a month.

How are the negotiations with the baddie going?

Did I leave a jacket at your house? Seonwhere in the trip East I lst a jacket. I know I had it when we got to Pittsburgh, must but I don't know what happened to it after that.

I think I've figured out why the so-called radicals in New York are so disorganized as compared to Chicago. I really think that Mayor Daley has helped the so-called movement.
